#### The Politics of Northern Ireland

#### Politics in Northern Ireland

The ongoing Irish peace process has renewed interest in the current social and political problems of Northern Ireland. In bringing together the issues of gender and inequality, Women Divided, a title in the International Studies of Women and Place series, offers new perspectives on women's rights and contemporary political issues. Women Divided argues that religious and political sectarianism in Northern Ireland has subordinated women. The book concludes with an in-depth critique of the current peace process and its implications for women's rights in Northern Ireland, arguing that women's rights must be a central element in any agenda for peace and reconciliation.

#### Peace Without Consensus

This book offers a uniquely comprehensive account of the conflict in Northern Ireland, providing a rigorous analysis of its dynamics and present structure and proposing a new approach to its resolution. It deals with historical process, communal relations, ideology, politics, economics and culture and with the wider British, Irish and international contexts. It reveals at once the enormous complexity of the conflict and shows how it is generated by a particular system of relationships which can be precisely and clearly described. The book proposes an emancipatory approach to the resolution of the conflict, conceived as the dismantling of this system of relationships. Although radical, this approach is already implicit in the converging understandings of the British and Irish governments of the causes of conflict. The authors argue that only much more determined pursuit of an emancipatory approach will allow an agreed political settlement to emerge.

#### Women Divided

This original and distinctive book surveys the political, economic and social history of Northern Ireland in the Second World War. Since its creation in 1920, Northern Ireland has been a deeply divided society and the book explores these divisions before and during the war. It examines rearmament, the relatively slow wartime mobilisation, the 1941 Blitz, labour and industrial relations, politics and social policy. Northern Ireland was the only part of the UK with a devolved government and no military conscription during the war. The absence of military conscription made the process of mobilisation, and the experience of men and women, very different from that in Britain. The book's conclusion considers how the government faced the domestic and international challenges of the postwar world. This study draws on a wide range of primary sources and will appeal to those interested in modern Irish and British history and in the Second World War.

# The Dynamics of Conflict in Northern Ireland

Ideologies and identities are central to the organisation of political life and political conflict, yet most empirical studies tend to obscure their significance. This failure to take the politics of identity seriously arises from an absence of adequate theory and method. This 1996 study draws on both social theory

and psychological (especially psychoanalytic) theory in an attempt to overcome these lacunae. First, it develops a novel theory and method for the analysis of ideology and identity. Second, it develops a detailed analysis of the politics of identity in Northern Ireland through focusing upon Unionist ideology and Unionist identities in crisis. The political conflict within Unionism is analysed through a consideration of the variety of unconscious rules drawn upon by political actors and citizens in the making of Northern Ireland's history of the late 1980s.

#### Northern Ireland in the Second World War

Has conflict in Northern Ireland kept political dimensions of religion alive, and has religion played a role in fuelling conflict? Conflict in Northern Ireland is not and never will be a holy war. Yet religion is more socially and politically significant than many commentators presume. In fact, religion has remained a central feature of social identity and politics throughout conflict as well as recent change. There has been an acceleration of interest in the relationship between religion, identity and politics in modern societies. Building on this debate, Claire Mitchell presents a challenging analysis of religion in contemporary Northern Ireland, arguing that religion is not merely a marker of ethnicity and that it continues to provide many of the meanings of identity, community and politics. In light of the multifaceted nature of the conflict in Northern Ireland, Mitchell explains that, for Catholics, religion is primarily important in its social and institutional forms, whereas for many Protestants its theological and ideological dimensions are more pressing. Even those who no longer go to church tend to reproduce religious stereotypes of 'them and us'. Drawing on a range of unique interview material, this book traces how individuals and groups in Northern Ireland have absorbed religious types of cultural knowledge, belonging and morality, and how they reproduce these as they go about their daily lives. Despite recent religious and political changes, the author concludes that perceptions of religious difference help keep communities in Northern Ireland socially separate and often in conflict with one another.

# Politics and Policy-making in Northern Ireland

It will be of interest to students of Irish politics and public policy, but more generally, from a comparative perspective, those with an interest in devolution and constitutional change.

#### Identity, Ideology and Conflict

She has both expounded the rich detail of the Northern Ireland and Irish-British conflicts and placed them in their regional and global contexts. Written by some of the leading scholars on peace and conflict in Ireland, the chapters in this edited volume build on Todd's work and are a testament to the thematic and methodological breadth and depth of her output. This book will be of interest to students and scholars of Irish and British history and politics, Peace and Conflict Studies, and the sociology of identity, conflict, and peacebuilding. # Religion, Identity and Politics in Northern Ireland

## Devolution and Constitutional Change in Northern Ireland

Whilst there are any number of books on the subject of Northern Ireland, few provide much guidance on how it has been handled by Westminster and Whitehall, or indeed the extent to which British governments and Parliament has tried to avoid having to handle the issue. This book provides a much needed historical context in which to assess contemporary approaches to the Northern Ireland problem and, in essays covering the period from the establishment of the Northern Ireland state to the present day, points to many often overlooked continuities in British policy.

#### The Politics of Conflict and Transformation

This collection adds to the extensive literature on Northern Ireland and Ireland by bringing together the leading academic and political figures working in the field and offering a comprehensive, multidisciplinary overview of the historical process. The topics discussed include the remote and proximate causes of the conflict, fresh developments within the two states on the island, the role of the Roman Catholic Church, the rise of the ecumenical movement and the impact of the 1985 Anglo-Irish Agreement on the triangular relationship between Dublin, Belfast and London. The volume concludes with an evaluation of likely impact of membership of the European Community on the conflict in Northern Ireland. The contributors to this book do not offer any easy solutions but provide a context in which the problem may be better understood by the international scholarly community and by the interested general reader.

#### Facets of the Conflict in Northern Ireland

Politics in Ireland is the first major text to provide an accessible and systematic analysis of the politics of Ireland: North as well as South. With the development of a new Northern Irish political system and increasing links across the island, the authors argue that the time is ripe to study together the two polities, which share so much of a common history but which have had very different evolutions through the 20th century. Drawing upon an exceptionally wide range of sources and their own original research, the authors deploy a thematic approach to the study of political institutions, political behaviour and public policy in both the Republic and Northern Ireland in order to produce a detailed, but highly readable, assessment of governance and politics in both political systems. This approach enables them both to outline the differences and similarities between the polities and to explain how they relate to the wider world, in particular to the UK and to Europe.

#### The Northern Ireland Question in British Politics

Civilization and culture have traditionally been regarded as mutually exclusive concepts. In this comparative case-study of Northern Ireland, Máiréad Nic Craith explores the commitment of unionists to a civic, 'culture-blind' British state; contrasting this with nationalist demands for official recognition of Irish culture. The 'cultural turn' in Northern Irish politics and the development of a bicultural infrastructure is examined here in the context of differing interpretations of equality and increasing demands for intercultural communication within, as well as between, communities.

# Politics in the Streets

Clearly and accessibly written, Dixon provides a lively introduction to the nature and politics of the Northern Ireland conflict and of successive attempts to resolve it. The comprehensively revised 2nd edition has been updated to take account of new information and an entirely new chapter has been added on implementing the Good Friday Agreement.

#### Northern Ireland and the Politics of Reconciliation

The common goal of integrated education in Northern Ireland is to bring Protestant and Catholic children together in schools in an attempt to foster an atmosphere of mutual understanding and respect. These integrated schools stress what the divided communities have in common, rather than what divides them. They remain, however, a small percentage of Northern Ireland's schools. There are many stories of the long discord in Northern Ireland between the Protestant and Catholic communities. Breathing the Same Air: Children, Schools, and Politics in Northern Ireland focuses on the stories of the integrated education movement, the context in which it began and continues to develop, and

an American researcher's experience as she learned of these stories. Dr. Abigail Stahl McNamee is an American educator who went to Northern Ireland for many years to write about the stories of the integrated education movement. She asks: "What families and schoolpersonnel have participated in the movement? What risks have they taken to do so? What church personnel and politicians have supported it? What do the children who attend an integrated school, and those who attend the State (Protestant) and Catholic schools in the same community, understand about the uniqueness of the school that they attend? Do their friendship patterns extend beyond their own school to the other schools in their community? How has the integrated education movement changed over the years? How can this movement resonate with Americans?"

#### Politics in Ireland

This book examines the evolution of British - Irish relations since 1921 and applies theories from political and social sciences, including international relations to the Irish/Northern Irish case. The book includes the generation and analysis of primary data on violence and constitutional debate; the analysis of primary sources such as state papers; and elite interviews with British and Irish officials, representatives of constitutional political parties in Northern Ireland, and leaders and activists of republican and loyalist parties/organisations. Part 1 looks at how the attempt to regulate the Irish nationalist challenge to the British state (through dominion status for the Irish Free State and partition) impacted on governance in both jurisdictions. The re-opening of the (Northern) Irish Question in the late 1960s is then analysed to demonstrate the continued primacy of opposing claims to national self-determination and their impact on subsidiary levels of conflict. The final part, covering the year 1985 to the present, then demonstrates how the relative equalization of national status, reflected in the bi-national, inter-governmental relationship, has been successful in regulating conflict by integrating vertically the bi-nationality at state, governmental, and societal levels. Finally, implications of the British-Irish approach are developed as contributions to the comparative theory and practice of ethno-national conflict regulation. Ã?Â?Â?Â?

## Culture and Identity Politics in Northern Ireland

In this book, Jonathan Tonge examines the reasons for that conflict; the motivations of the groups involved and explores the prospects for a post-conflict Northern Ireland. The book: assesses the motivations and campaigns of the IRA, UVF and UDA and other armed groups discusses what each paramilitary group achieved through violence analyses the continuing controversies surrounding the Northern Irelands dirty war outlines the extent of collusion between British security forces and loyalist paramilitaries explores how governments and political parties shaped the peace process scrutinizes prospects for the political development of unionism and nationalism within a devolved power sharing framework examines whether the sectarian divide is strengthening or weakening concludes by assessing whether Northern Ireland can move permanently from violence and instability to become a normal peaceful polity, in which the war is merely a historic relic Written by an acknowledged expert in the field, Northern Ireland combines incisive analysis, original research and a lucid style to provide an important assessment of what has been described as an 800 year old problem.

The story of the making and eventual implementation of a city and regional plan for the Londonderry area makes fascinating reading. Published in 1968, just before the outbreak of the recent 'troubles', it became the basis for subsequent plans implemented by officials of the Northern Ireland Department of the Environment, the Northern Ireland Housing Executive and dedicated community leaders. Their often heroic commitment to the future of the city and its environs transcends even the worst days of civil strife. The author was one of a small team that made the plan and he places it in context, explains how it came to be made and records the difficulties of planners working in the political circumstances that prevailed. Against the background of the general social, economic and physical conditions of the city and region, he focuses on the housing crisis before elaborating on the making of the plan in particular. Professor McSheffrey stresses that although the story may be of interest to planners and development professionals, it is not an academic study of the planning process. He hopes it will introduce general readers to the importance of planning and the complex social and ethical issues inherent in the process. Planning Derry for example, involved value judgements concerning people and political and religious views in Northern Ireland at the time, but he has tried to be objective and avoid bias or the espousal of a particular political viewpoint. The book is, above all, about the dedication of individuals who believed their planning efforts could make a difference and provide better living conditions and choices for the people of the area. McSheffrey concludes on an optimistic note concerning the future place of Derry in Ireland. As the peace process unfolds, he hopes that perhaps the people of Derry, as they continue to develop and rebuild their city, might become a symbol of liberation from the past and of expectations of a peaceful and prosperous future for all Irish people.

## Politics and Performance in Contemporary Northern Ireland

In 1997 Feargal Cochrane provided the first comprehensive account of unionist politics from the Anglo-Irish Agreement through to the forum elections and multiparty talks of July 1996. In this new edition of Unionist Politics and the Politics of Unionism, an extra chapter takes the story forward from 1997 until the UUP leadership challenge of March 2000. The analysis concentrates on the trials and tribulations of unionist politics throughout this period, concentrating on the Good Friday Agreement (GFA) of 10 April 1998 and its faltering implementation. The chapter ends with some observations concerning the state of unionist politics today and the extent to which they have moved on since the first edition of the book was published.

# Planning Derry

#### Beyond the Rhetoric

Following the 1998 peace agreement in Northern Ireland, political violence has dramatically declined and the region has been promoted as a model for peacemaking. Human rights discourse has played an ongoing role in the process but not simply as the means to promote peace. The language can also become a weapon as it is appropriated and adapted by different interest groups to pursue social, economic, and political objectives. Indeed, as violence still periodically breaks out and some

ethnocommunal and class-based divisions have deepened, it is clear that the progression from human rights violations to human rights protections is neither inevitable nor smooth. Human Rights as War by Other Means traces the use of rights discourse in Northern Ireland's politics from the local civil rights campaigns of the 1960s to present-day activism for truth recovery and LGBT equality. Combining firsthand ethnographic reportage with historical research, Jennifer Curtis analyzes how rights discourse came to permeate grassroots politics and activism, how it transformed those politics, and how rights discourse was in turn transformed. This ethnographic history foregrounds the stories of ordinary people in Northern Ireland who embraced different rights politics and laws to conduct, conclude, and, in some ways, continue the conflict—a complex portrait that challenges the dominant postconflict narrative of political and social abuses vanquished by a collective commitment to human rights. As Curtis demonstrates, failure to critique the appropriation of rights discourse in the peace process perpetuates perilous conditions for a fragile peace and generates flawed prescriptions for other conflicts.

#### Northern Nationalism

The repeated crises of devolved power sharing in the face of continued paramilitary activity and persistent sectarianism have hindered attempts to shape a new Northern Irish politics, based upon peace and consensus. In this important new book, Jonathan Tonge analyzes the underlying issues, explores the ways in which rivalries within and between unionism and nationalism perpetuate instability, and assesses the potential and limitations of consociational deals like the Good Friday Agreement in conflict resolution.

## Unionist Politics and the Politics of Unionism Since the Anglo-Irish Agreement

First published in 1997, this volume responded to the peace process of the 1980s and 1990s between Great Britain and Northern Ireland, emerging just prior to the 1998 Good Friday Agreement. It constituted one of the first major academic examinations of the attempts to bring peace to Northern Ireland in the 1990's, and explores the historical origins of the process, before moving towards a critical account of the role of political parties in the development of the peace process. Critics have argued equally that the process was a sham, tactically repositioning Irish republicanism, and that it provided a framework for reconciliation or even conflict resolution. This book outlines the political changes which allowed the peace process to develop, along with analysing specific themes divided into three broad sections: the general aims of the peace process, the political perspectives and the issues under discussion. Aiming to promote discussion, these contributors explore the origins and function of the peace process, followed by an analysis of political perspectives including the Unionists, the SDLP and Irish Republicanism. Finally, they consider key issues of interest for the peace process, including the ever-present border debate, security strategies, education, and economics, whilst Rachel Ward makes the case for the skilled contributions of women available to formal politics.

#### Identity in Northern Ireland
