Sections include: the Officer's Aid Memoire containing notes of the training course at one of the officer training schools; Notes for medical officers and treatment of battle casualties afloat; Notes for captains on taking command of their first ship; Notes for commanding officers; Notes on the handling and safety of ships and notes on dealing with disobedience and mutiny. While suffused with nostalgia and charm, the various contents of this book are an authentic presentation of matters of training, authority and deportment in the wartime navy. The book is sure to appeal not only to those who served in the war or had a relative who was

in the officer class, but also to anyone who wants to gain a greater understanding of the day-to-day administration of the wartime navy.

#### Foreign Office correspondence 1906

Rigidly organised and harshly disciplined, the Georgian Royal Navy was an orderly and efficient fighting force which played a major role in Great Britain's wars of the 18th and early 19th centuries. This concise book explores what it was like to be a sailor in the Georgian Navy – focusing on the period from 1714 to 1820, this book examines the Navy within its wider historical, national, organisational and military context, and reveals exactly what it took to survive a life in its service. It looks at how a seaman could join the Royal Navy, including the notorious 'press gangs'; what was meant by 'learning the ropes'; and the severe punishments that could be levied for even minor misdemeanours as a result of the Articles of War. Military tactics, including manning the guns and tactics for fending off pirates are also revealed, as is the problem of maintaining a healthy diet at sea – and the steps that sailors themselves could take to avoid the dreaded scurvy. Covering other fascinating topics as wide-ranging as exploration, mutiny, storms, shipwrecks, and women on board ships, this 'Sailor's Guide' explores the lives of the Navy's officers and sailors, using extracts from contemporary documents and writings to reconstruct their experiences in vivid detail.

#### How to Survive in the Georgian Navy

In contrast to every other book about the conflict Andrew Lambert's ground-breaking study *The Crimean War: British Grand Strategy against Russia, 1853-1856* is neither an operational history of the armies in the Crimea, nor a study of the diplomacy of the conflict. The core concern is with grand strategy, the development and implementation of national policy and strategy. The key concepts are strategic, derived from the works of Carl von Clausewitz and Sir Julian Corbett, and the main focus is on naval, not military operations. This original approach rejected the 'Continentalist' orthodoxy that dominated contemporary writing about the history of war, reflecting an era when British security policy was dominated by Inner German Frontier, the British Army of the Rhine and Air Force Germany. Originally published in 1990 the book appeared just as the Cold War ended; the strategic landscape for Britain began shifting away from the continent, and new commitments were emerging that heralded a return to maritime strategy, as adumbrated in the defence policy papers of the 1990s. With a new introduction that contextualises the 1990 text and situates it in the developing historiography of the Crimean War the new edition makes this essential book available to a new generation of scholars.

### How to Keep Well in Wartime

"This work deals with Britain's last throw of the dice in the American Revolutionary War. Comprising six volumes, it contains a fully edited transcript of almost all the papers that were written by, or came before, Lord Cornwallis during his command in the south. The papers cover the siege of Charlestown, his tenuous occupation of South Carolina and Georgia, the autumn, winter and Virginia campaigns, and ultimately his capitulation at Yorktown. Among a mass of matters that are also covered are Craig's occupation of Wilmington, his operations there, the Spanish threat to East Florida, and the eventual collapse of British authority elsewhere in the south. The papers are arranged in 14 parts and 68 chapters. In view of the numberless inaccuracies published about the war most parts begin with an introductory chapter, the purpose of which is to present the papers in an accurate, balanced and dispassionate way. Whether such chapters are seen to succeed will, inevitably, depend to a degree on the perspective from which the papers are viewed. The papers open the door to re-evaluating certain aspects of the war. The introductory chapters very briefly provide pointers besides addressing certain important considerations that have long gone by default"--Publisher's description.

### The Penguin Historical Atlas of the British Empire

Following the United States Declaration of Independence in 1776, the governing doctrines and policies of the States lacked cohesion. "The Federalist", as it was previously known, was constructed by American statesman Alexander Hamilton, and was intended to catalyse the ratification of the United States Constitution. Hamilton recruited fellow statesmen James Madison Jr., and John Jay to write papers for the compendium, and the three are known as some of the Founding Fathers of the United States. Alexander Hamilton (c. 1755–1804) was an American lawyer, journalist and highly influential government official. He also served as a Senior Officer in the Army between 1799-1800 and founded the Federalist Party, the system that governed the nation's finances. His contributions to the Constitution and leadership made a significant and lasting impact on the early development of the nation of the United States.

Based largely on communications intelligence, the U-boat situations and trends were designed to inform a small number of senior officers and high officials of the latest events and developments in the Allied war against the U-boats. The Battle of the Atlantic and the war against the U-boats was the longest and the most complex naval battle in history. In this huge conflict which sprawled across the oceans of the world the U-boats sank 2,828 Allied merchant ships while the Allies destroyed more than 780 German U-boats. These documents relate on a weekly, and in some cases a daily, basis exactly what the Allies knew concerning the activities of the U-boats during the Battle of the Atlantic.

## Emergency Response Guidebook

A map is a snapshot of a place, a city, a nation or even the world at a given point in time - fascinating for what they tell us about the way our ancestors saw themselves, their neighbours and their place in the world. This magnificent collection, drawn from seven centuries of maps held in the National Archives at Kew, looks at a variety of maps, from those found in 14th Century manuscripts, through early estate maps, to sea charts, maps used in military campaigns, and maps from treaties. The text explores who the mapmakers were, the purposes for which the maps were made, and what it tells us about the politics of the time. Great images are accompanied by compelling stories. Featured is a woodcut map of 16th Century London, a map of where the bombs fell during the Second World War, and a map the first American settlers' drew when they were attempting to establish a new empire on Roanoke Island, off the coast of what is now North Carolina. Richly illustrated with large scale reproductions of the maps, the book also includes some of the more amusing or esoteric maps from the National Archives, such as the map of the Great Exhibition in 1851 that was presented on a lady's glove, a London Underground map in the form of a cucumber, and a Treasure Island map used to advertise National Savings. This is a fascinating and unusual journey through the world of maps and mapmakers.
