Serial Killers

On July 14th, 1966, Richard Franklin Speck swept through several student nurses' townhouse like a summer tornado and changed the landscape of American crime. Includes graphic photos Peter Woodcock was Canada's youngest serial killer when at the age of seventeen he brutally raped and murdered two boys and a girl between the ages of four and nine. He was never put on trial by "reason of insanity" and instead was confined for 34 years in a criminal psychiatric facility and offered treatment. On July 13, 1991 he finally had earned his first day pass ever and allowed to briefly go off the facility grounds into town to visit a DQ for an ice cream. What Woodcock did within the first hour of his first day pass stunned many people and made national headlines.

Peter Woodcock

On November 6, 2001, Dr. Andrew Bagby was found dead in a parking lot for day use at Keystone State Park in Derry Township, Pennsylvania. He had been shot to death. There were five gunshot wounds as well as blunt force trauma to the back of the head. He had been shot in both the face and chest as well as the back of the head, back and buttocks. He was left face down in the parking lot in his scrubs, next to his Toyota Corolla. He died there. The bizarre murder case of Andrew Bagby entails far more than death, although it has that threefold. It also brought to light a woefully inept Canadian legal system and the frighteningly dark mental descent of a woman scorned. While evidence was steadily mounting against her, Dr. Shirley Turner dropped everything, left her car, apartment and every worldly possession, and went back to Canada. By the time Pennsylvania had an open warrant on her, she was in St. John's, Newfoundland, Canada. There, she gave birth to Andrew's son, Zachary. While in jail, she wrote to a judge. Against legal precedent, this judge wrote her back and gave her legal advice on how to proceed with her case. The United States presented evidence of her crimes and their investigation and findings thus far. It was overwhelming. Her lies were exposed, her gun casings matched and witnesses placed her car next to his at the time of the murder. What happened next is one of the strangest decisions in legal history.

Shirley Turner

Most news articles and television true crime shows skim over the vile details of truly horrible crimes. In my books I don't gloss over the facts, regardless of how disgusting they may be. I try to give my readers a clear and accurate description on just how demented the killers really were. I do my best not to leave anything out. The stories included in these books are not for the squeamish. What you are about to read are Volumes 4, 5, and 6 of the True Crimes Case Histories Series. The stories in this collection will make you realize just how fragile the human mind can be. A sampling of the 36 stories include: *The Darlington Cannibal*: The story of a young English man that had plans to become the UK's most notorious serial killer, but couldn't keep his mouth shut after his first kill and bragged to over twenty of his friends. *The Carnival Cult*: A group of four young men who believed they could do anything they wanted because their lord Satan protected them. Satan apparently couldn't protect them from prison. *Dead in the Water*: A father of eight children lured women to his boat, raped them, and threw them overboard. Ingenious forensic science was eventually used to catch the killer. *Consumed by Desire*: One story of a young man that couldn't handle being rejected by his teenage girlfriend was suggested to me by a reader whose daughter had a close-call with the killer. *The Crossbow Killer*: A young, intelligent man that would rather kill his entire family with a crossbow than tell his girlfriend that he had been lying to her. *Divine Justice*: a young girl that ran away from her Seattle home in the 1970s. Authorities found her eight weeks later stuffed inside a duffel bag. *The Copper Gulch Killer*: A sixteen-year-old prodigy child is found with five gunshots from three different guns, but police are convinced there was only one killer. John Thomas Straffen – Britain's longest-serving prisoner – was the first patient to escape from Broadmoor Hospital and be prosecuted for a crime committed on the run. He killed within hours.

Prior to this, at his home in Bath, he was dismissed as a loner, an imbecile, a 'child trapped in an adult's body'. On the afternoon of Sunday 15 July 1951, John Straffen strangled 8-year-old Brenda Goddard as she picked flowers. Three weeks later, he committed a similar murder before inadvertently confessing to the police. Faced with a serial killer with a mental age of 10, whose motive apparently was nothing more than to annoy the police, the court sent Straffen to Broadmoor Institute, as it was known then, for the criminally insane. But on 29 April 1952, having spent only six months at the Institute, he escaped in a carefully planned bid for freedom that should not have been possible. During these four hours on the run, hoping to show the authorities he could be free and not commit further offences, Straffen instead murdered 5-year-old Linda Bowyer. Prime Minister Winston Churchill and his beleaguered government intervened to prevent Straffen walking free again. But was Straffen insane? Using previously unpublished documents, including government classified papers, author Gordon Lowe paints a vivid picture of a man who shocked the nation and confused the courts with his crimes.
