# Theory and Reform in the European Union

This substantially updated and revised edition offers a comprehensive overview of the challenges confronting the political system as well as the international politics of the European Union. It draws from a rich spectrum of regional integration theories to determine what the Union actually is and how it is developing. The book examines constitutional politics of the European Union, from the Single European Act to the Treaty of Nice and beyond. The ongoing debate on the future of Europe links together questions of democracy and legitimacy, competences and rights, and the prospects for European polity-building. The aim is to contribute to a better understanding of the emerging European polity and the questions that further treaty reform generate for the future of the regional system. The authors also assess the evolving European security architecture, the limits and possibilities of a genuine European foreign, security and defence policy, and the role of the European Union in the post-Cold War international system. Common themes involve debates about stability and instability, continuity and change, multipolarity and leadership, co-operation and discord, power capabilities and patterns of behaviour. The book traces the defining features of the 'new order' in Europe and incorporates an analysis of the post-September 11 context. This major new edition will be of particular interest to academics, policy-makers and students with an interest in the politics and governance of contemporary Europe, as well as to those pursuing a career in international affairs.

# Neighborhood Challenge

One of the intriguing questions of the post-Cold War era has been whether the EU will play a major global role in world politics as non-traditional threats and challenges came to the forefront. Launching new policies such as the Common Foreign and Security Policy, the European Security and Defence Policy and the European Neighborhood Policy (ENP) have been considered important steps in the EU's evolution as a regional and possibly global actor. Neighborhood Challenge analyzes critical aspects of the European Union's relations with its neighbours, by extending its analysis beyond the ENP. Unlike existing books on the subject, the volume covers the entire neighborhood from Russia, Ukraine, and Belarus to North Africa; from the Western Balkans to the South Caucasus and Central Asia. Such an extensive overview of EU policies toward its neighbors is a timely and valuable contribution to European Studies literature. This book can be used as a tool for both academicians and practitioners who specialize in European foreign and security policy; as a textbook in European Union foreign policy courses both at the undergraduate and graduate level; and as a comprehensive reference book for postgraduate students writing dissertations on European foreign and security policy in general and European Neighborhood Policy in particular. The contributions analyze challenges and prospects posed by countries neighboring the EU and the effectiveness of EU policy in dealing with these agendas. Region-focused chapters examine the EU's politics toward the Western Balkans, Middle East, CIS, and the Black Sea; country-focused chapters explore aspects of Russia, Ukraine, Uzbekistan, Iran, Bosnia, Kosovo; and thematically-focused chapters deal with energy security, organized crime, and other issues. Neighborhood Challenge is intended to contribute to the existing literature on EU foreign and security policy in two ways: First, its material is not restricted to the ENP. Instead, it addresses all EU neighbors in a large region and their position in European security. The authors argue that not only the countries in the immediate neighborhood of the EU but also those located in relatively far away regions have a role to play in European Union foreign affairs. Secondly, many of the contributions were written by experts living in countries which neighbor the EU. Their contributions lend new ideas and insight to the relevant literature on EU security and foreign policy.

#### The European Union's Roles in International Politics

This new volume develops a conceptual framework for considering and evaluating the roles played by the EU in international politics, drawing upon the literatures of role analysis, international relations

and European integration. It pays particular attention to five aspects of role analysis: role conceptions, origins of roles, role institutionalization, role performance and role impact. These form themes running through the volume and are dealt with in individual contributions as appropriate. It also presents fresh applications and empirical case studies that support the conceptual framework and demonstrate the uses of role analysis in relation to the EU and its international activities, and its capacity to inform investigation from different perspectives and standpoints. By taking this approach and by providing both conceptual and empirical argument, this book delivers an innovative perspective on the analysis of the European Union as an international actor, and on the ways in which EU actions are formed and have impact. It also establishes a research agenda based on rigorous development of the framework for role analysis, and demonstrates the ways in which this agenda might be furthered.

### Where is Nato Going?

Since the end of the Cold War, and especially since September 11 2001, the future of NATO has been the subject of intense debate. This book brings together a group of international relations specialists in order to offer fresh perspectives on the Alliance's current and future purposes and roles. Rather than revisiting long-standing debates in areas such as NATO enlargement, the contributors focus instead on relevant contemporary issues. These include the prospects for NATO 'going global', NATO's role in the US-led 'war on terror' and the challenges posed by the transatlantic 'capabilities gap' and the emergence of a military dimension to the European Union. The paradox facing NATO today is that, whilst it is busier than it has ever been before, it still does not appear, to many observers, to have found a viable core role or roles in the contemporary international security arena. By exploring key issues and debates on NATO's current agenda, this book helps us to better understand the prospects for its long-term survival and viability. This book was previously published as a special issue of the leading journal, Contemporary Security Policy.

#### The Actors of Postnational Rule-Making

Despite its centrality to academic discussions of power and influence, there is little consensus in legal scholarship over what constitutes an actor in rule-making. This book explores the range of actors involved in rule-making within European Union law and Public International law, and focuses especially on actors that are often overlooked by formative and doctrinal approaches. Drawing together contributions from many scholars in various fields the book examines such issues as the accommodation of new actors in the process of postnational rule-making, the visibility or covertness of actors within the process, and the role of social acceptance and legitimacy in postnational rule-making. In its endeavour to render and examine the work and effect of actors often side-lined in the study of postnational rule-making, this book will be of great use and interest to students and scholars of EU law, international law and socio-legal studies.

#### From Superpower to Besieged Global Power

In a much-needed reality check of the current state of U.S. global power, leading scholars and policy analysts from nine countries assess the impact of the Bush Doctrine on world order; explain how the United States reached its current low standing internationally; and propose ways that the country can repair the untold damage wrought by ill-conceived and incompetently executed security and foreign policies. ### Japan and Enlarged Europe

In parallel, their respective domestic and international positions have changed. The EU has integrated ten new members, adopted a Constitution and developed a security and defence policy. Japan has widened its international and security role and reorganised most of its economic policies. Therefore, Japan and the enlarged European Union are actors and partners in the process of global governance. This book addresses the cooperation between Japan and the enlarged European Union for a more secure world, sustainable development and global governance. It gathers contributions from European and Japanese

experts who have established a permanent network on this topic and meet every year for seminars in Brussels under the aegis of the Trans European Policy Studies Association (TEPSA) and its Belgian member organisation Study Group on European Policies (SEP-GEPE), with the support of the Japan Foundation. The book is a joint Japanese-European contribution to the Year of Japan-European Union People-to-People Exchanges declared in 2005.

#### Europe: A Civilian Power?

What is the European Union international role and identity becoming after the cold war, September 11th and the transatlantic rift? ### European Security and Defence Policy

## Psychology of a Superpower

With the collapse of the Soviet Union, the United States was left as the world's sole superpower, which was the dawn of an international order known as unipolarity. The ramifications of imbalanced power extend around the globe—including the country at the center. What has the sudden realization that it stands alone atop the international hierarchy done to the United States? In Psychology of a Superpower, Christopher J. Fettweis examines how unipolarity affects the way U.S. leaders conceive of their role, make strategy, and perceive America's place in the world. Combining security, strategy, and psychology, Fettweis investigates how the idea of being number one affects the decision making of America's foreign-policy elite. He examines the role the United States plays in providing global common goods, such as peace and security; the effect of the Cold War's end on nuclear-weapon strategy and policy; the psychological consequences of unbalanced power; and the grand strategies that have emerged in unipolarity. Drawing on psychology's insights into the psychological and behavioral consequences of unchecked power, Fettweis brings new insight to political science's policy-analysis toolkit. He also considers the prospect of the end of unipolarity, offering a challenge to widely held perceptions of American indispensability and asking whether the unipolar moment is worth trying to save. Psychology of a Superpower is a provocative rethinking of the risks and opportunities of the global position of the United States, with significant consequences for U.S. strategy, character, and identity.

#### The Superpowers

The Superpowers traces the development of the USA and Russia (later USSR) from 1898 through to 2000, placing the Cold War, from inception to ending, into the wider social, economic and political context. This is the first history of the two major participants and their relationship throughout the twentieth century. The Superpowers: explores the intertwining history of the two powers chronologically and includes discussion of: \* the inheritance of the two great powers and their imperial background \* World War One and the Russian Revolution \* Capitalism and Socialism \* World War Two and its impact

#### India as an Emerging Power

These essays examine India's relations with key powers including the Russian Federation, China and the USA and with key adversaries in the global arena in the aftermath of the Cold War. One positive relationship is that of India's relations with Israel since 1992.

### Soldiers and Civil Power

Since the Cold War, peace operations have become the core focus of many Western armed forces. In these operations, the division between civil and military responsibilities often rapidly blurs. Among policy makers and in military circles, a debate has erupted regarding the scope of the military in stabilizing and reconstructing war torn societies. Should soldiers, who primarily prepare for combat duties, observe a strict segregation between the "military sphere" and the "civilian sphere" or become involved in "nation building"? Should soldiers be allowed to venture into the murky arena of public security, civil administration, humanitarian relief, and political and social reconstruction? In Soldiers and Civil Power, Thijs Brocades Zaalberg draws on military records and in-depth interviews with key players to examine international operations in the 1990's in Cambodia, Somalia, Bosnia, and Kosovo. Focusing his historical analysis on the experiences of various battalions in the field, he reveals large gaps between this tactical level of operations, political-strategic decision making and military doctrine. By comparing peace operations to examples of counterinsurgency operations in the colonial era and military governance in World War II, he exposes the controversial, but inescapable role of the Western military in supporting and even substituting civil authorities during military interventions. At a time when US forces and its allies struggle to restore order in Iraq and Afghanistan, Brocades Zaalberg's in-depth study is an invaluable resource not only for military historians, but anyone interested in the evolving global mission of armed forces in the twenty-first century.

# US Foreign Policy and Defense Strategy

Safe from the battlefields of Europe and Asia, the United States led the post–World War II global economic recovery through international assistance and foreign direct investment. With an ardent decolonization agenda and a postwar legitimacy, the United States attempted to construct a world characterized by cooperation. When American optimism clashed with Soviet expansionism, the United States started on a path to global hegemony. In US Foreign Policy and Defense Strategy, the authors analyze the strategic underpinnings of hegemony, assess the national security establishment that sustains dominance, consider the impact on civil-military relations, and explore the intertwining relationships between foreign policy, defense strategy, and commercial activities. Eschewing conventional analyses, the volume not only identifies drivers and continuities in foreign policy, but it also examines how the legacy of the last sixty-five years will influence future national security policy that will be characterized by US leadership in an increasingly competitive world. From civil-military relations to finance, and from competing visions of how America should make war to its philosophy of securing peace through reconstruction and reconciliation, US Foreign Policy and Defense Strategy offers unique insights into the links between military and commercial power as it charts the rise of a historical rarity: the incidental superpower. This accessibly written book is suitable for students and general readers as well as scholars.

# International Relations and the European Union

This text explores the ways in which the European Union frames and conducts its international relations. Each chapter deals with the three key themes of the volume - the EU as a sub-system of international relations, the EU and the processes of international relations, and the EU as a power.

#### Rethinking the European Union

Rethinking the European Union draws together contributors from across Europe to reflect upon methods of conceptualising the European Union within both changing global and European contexts. The book takes the themes of institutions, interests and identities as its organising framework within which each contributor offers a distinctive commentary on the EU. The outcome is a text that goes

beyond an exploration of the existing methods of conceptualising the European integration process and reflects upon the nature of the EU itself.

#### Perceptions and Policy in Transatlantic Relations

In this book, experts from both sides of the Atlantic, examine the recent tensions between Western Europe and the United States over such issues as transatlantic security, policies towards terrorism and relations with Russia and the former Soviet Union, against the broader background of perceptions and misperceptions in transatlantic relations. Drawing on Professor Robert Jervis' work, Perceptions and Misperceptions in International Politics, this book examines whether Jervis' thesis has a new relevance given the current challenges in transatlantic relations. Some of the issues examined include: perceptions and misperceptions in general focusing on US foreign policy, issues of decision-making and implementation and issues of alliance management the capacity of the United States and the European Union to cooperate effectively within the broader transatlantic framework studies focusing on the 'alliance security dilemma' and the transatlantic security community case studies of transatlantic relations in the 'war on terror' and relations with Russia the present and future of the 'western alliance'. Providing a global and multilateral analysis from American and European perspectives and exploring fields of cooperation and competition, Perceptions and Policy in Transatlantic Relations will be of strong interest to students of International Relations, American politics and European politics.

# Power and Superpower

This book develops the idea that since decolonisation, regional patterns of security have become more prominent in international politics. The authors combine an operational theory of regional security with an empirical application across the whole of the international system. Individual chapters cover Africa, the Balkans, CIS Europe, East Asia, EU Europe, the Middle East, North America, South America, and South Asia. The main focus is on the post-Cold War period, but the history of each regional security complex is traced back to its beginnings. By relating the regional dynamics of security to current debates about the global power structure, the authors unfold a distinctive interpretation of post-Cold War international security, avoiding both the extreme oversimplifications of the unipolar view, and the extreme deterritorialisations of many globalist visions of a new world disorder. Their framework brings out the radical diversity of security dynamics in different parts of the world.

### Regions and Powers

Drawing upon a multi-disciplinary methodology employing diverse written sources, material practices and vivid life histories, Faith in the family seeks to assess the impact of the Second Vatican Council on the ordinary believer, alongside contemporaneous shifts in British society relating to social mobility, the sixties, sexual morality and secularisation. Chapters examine the changes in the Roman Catholic liturgy and Christology; devotion to Mary, the rosary and the place of women in the family and church, as well as the enduring (but shifting) popularity of Saints Bernadette and Thérèse. Appealing to students of modern British gender and cultural history, as well as a general readership interested in religious life in Britain in the second half of the twentieth century, Faith in the family illustrates that despite unmistakable differences in their cultural accoutrements and interpretations of Catholicism, English Catholics continued to identify with and practise the 'Faith of Our Fathers' before and after Vatican II.

### Germany as a Civilian Power?

Arguing that we live in a world where great powers - such as China and the EU - are not helpless in the face of the United States, this text contends that the other major nations of the world must work alongside the US in order to counter-balance America's current dominance of the international political scene.

#### The United States and the Great Powers
