First published in 1979, *Supplies Management for Health Services* looks at the characteristics and problems of hospital suppliers and examines the way in which the hospital and the National Health Service deal with supplies problems and relations with suppliers. Beginning with a description of the National Health Service and its suppliers' organisations and the role of the Department of Health and Social Security in this field, the book then reports on the detailed studies made over two years of the suppliers' problems of ten London area health authorities and ten London manufacturers of medical equipment. The NHS situation is then contrasted with the suppliers' situation in three non-health organisations and with the health supplies situation in France and West Germany. The final part of the book analyses the information obtained, proposes a means of assessing supplies systems, and evaluates the NHS situation. This is followed by the realistic proposals for reform, advocating a system similar to that used in British defence services, based on a central procurement agency, close cooperation with private manufacturers, and manufacture by government where necessary. This book will surely interest students of economics and global health.

Supplies Management for Health Services

Purchasing for health is more than contracting the best value for money services. Contracting is one means to the end of improving health and preventing illness. Public purchasing is a new task and an emerging health management discipline. This book gives an introduction to the theory and practice of the subject, describes key issues and outlines concepts and practical approaches to purchasing for health. It judges different approaches to purchasing against a view of the purpose of NHS commissioning, and of commissioning organizations as service businesses. The book is mainly for UK health purchasing managers working for health authorities and for primary care physicians or centres with a purchasing fund. The book also makes available some of the experience of seven UK NHS integrated health purchasers (commissioning agencies) in forming and performing joint district health authority (DHA) and family health services authority (FHSA) commissioning. Parts of the book draw on a purchaser development programme for these agencies, and this accounts for the emphasis on practical problems and solutions in the later chapters.

Adopting a procurement perspective, the authors explain how complex performance means not just coping with the dynamics of buyer-supplier relationships, but incorporates the shift from production orientation towards availability of bundled services such as maintenance and upgrade delivered over extended, often multi-decade timeframes. The strength of 'PCP' is its empirical case-based support for new business models based on through-life management, availability contracting and service support which challenge simplistic notions of dyadic, hierarchical relationships and transfer of risk to the supply base. This unique publication is essential reading for scholars and practitioners seeking to understand the context of innovation and supply as a coordinated and integrated approach to managing and procuring complex performance.

Building for the Future
