theory building, one chapter explains a number of findings in the child abuse and neglect literature using propositions derived from evolutionary biology; another paper distills propositions from several theoretical traditions. In conjunction with these efforts, several chapters report research designed to test competing propositions. Chapter references and research data are provided.

The long-term human and fiscal consequences of child abuse and neglect are not relegated to the victims themselves -- they also impact their families, future relationships, and society. It should also clarify the causal pathways related to child abuse and neglect and, more importantly, assess efforts to interrupt these pathways. New Directions in Child Abuse and Neglect Research identifies four areas to look to in developing a coordinated research enterprise: a national strategic plan, a national surveillance system, a new generation of researchers, and changes in the federal and state programmatic and policy response.

Children and Adolescent's Experiences of Violence and Abuse at Home

Drawing on theoretical explanations, international research, and practice experience, they highlight examples of good practice and holistic responses, including primary, secondary, and tertiary prevention. Written in a clear and direct style, this book will appeal to students and scholars of criminology, sociology, and social work engaged in studies of domestic and family violence, violence against women, and intimate partner violence. It will be an invaluable resource for those designing, coordinating, and conducting service responses.

Domestic and Family Violence
