Der evangelische Papst

Politi's account balances the perspectives of Pope Francis's supporters, Benedict's sympathizers, and those disappointed members of the laity who feel alienated by the institution's secrecy, financial corruption, and refusal to modernize. Politi dramatically recounts the sexual scandals that have rocked the church and the accusations of money laundering and other financial misdeeds swirling around the Vatican and the Italian Catholic establishment, and how Pope Francis's attempts to address these crimes has been met with resistance from entrenched factions. He writes of the decline in church attendance and vocations to the priesthood as the church continues to prohibit divorced and remarried Catholics from receiving Communion. He visits European parishes where women perform the functions of missing male priests—and where the remaining parishioners would welcome the ordination of women, if the church would allow it. Pope Francis's emphasis on pastoral compassion for all who struggle with the burden of family life has also provoked the ire of traditionalists. He knows from experience what life is like for the poor in South America and elsewhere, and highlights the contrast between the vital, vibrant faith of these parishioners and the disillusionment of European Catholics. As Pope Francis and his supporters are locked in battle with the defenders of the traditional hard line and with ecclesiastical corruption, the future of Catholicism is at stake—and it is far from certain Francis will succeed in saving the institution from decline.

Pope Francis Among the Wolves

Cardinal Jorge Bergoglio was chosen as the next Pope in one of the shortest conclaves in history. He is the first Pope Francis, the first Jesuit Pope, the first Pope to come from Latin America. Who is this man, and how did he come to such high position? This book begins with the arrival of Bergoglio's family in Buenos Aires in 1929, travelling from Italy, explores his childhood as one of a family of five, his first job as a factory cleaner and the bout of pneumonia which forced him to reassess his life completely. Then from his early days as a seminarian through his experience as a teacher of psychology and literature, through to his consecration as a cardinal by Pope John Paul II, Bergoglio shares his experiences of

faith and life. The difficult subjects are met head on, from the declining numbers of priests to celibacy and even the sex abuse scandals that have rocked the church - and through it all, Bergoglio's humble approach and desire to live an austere and faithful life shine through. This is a Pope who will not allow himself to be fitted to a traditional mould - and the world waits with bated breath to see what his time as leader of the world's largest church will bring.

By any reckoning, the papacy of Pope Benedict XVI was extraordinary, with moments of high drama. Not the least of these was his resignation from office in February 2013, the first papal resignation in 500 years. But who is Joseph Ratzinger? In this definitive biography, based on meticulous historical research and many hours of taped interviews with his subject, Peter Seewald shows the exceptional circumstances in which the exceptionally talented son of a Bavarian policeman became the first German pope for 950 years. In this first volume, covering the years 1927-1965, we witness Joseph Ratzinger's early days, living above his father's police station. Ratzinger came to adulthood through the years of National Socialism. Though hostile to the rise of Hitler, his family knew well about Dachau and Ratzinger himself was conscripted into the Hitler Youth. Joseph Ratzinger proved to be a man of exceptional intellectual gifts and by the time of the Second Vatican Council (1962-1965) he was already noted as one of the outstanding intellects present and was nominated a 'peritus' or theological expert. This was also the time of the start of his friendship with the Swiss theologian Hans Küng who was to become his nemesis. Of his predecessor, Pope Francis has said: 'Pope Benedict was a great Pope, great for the penetration of his intelligence, great for his important contribution to theology, great for his love of the Church and human beings, great for his virtues and faith'. Even in this first volume, we begin to understand how this came to be true.

The Eucharist originated at the Last Supper of Jesus with his disciples. It is based on the prayer of thanksgiving that Jesus pronounced over the bread and wine at that meal. "Eucharist" means "thanksgiving", "praise", and "blessing". The Church celebrates the Eucharist as a memorial of the death and Resurrection of Jesus Christ, which is more than a remembrance of the Last Supper of Jesus with his disciples. In the Eucharist the sacrifice of our redemption becomes present sacramentally. In the past, dogmatic theology has treated the meaning of the Eucharist while disregarding the form of its liturgical celebration, whereas liturgical studies have been content with only the latter. Yet the two cannot be separated, any more than liturgy and dogma or pastoral practice and doctrine can be understood without the other. The Church's liturgy is not something external to Christian revelation, but rather, as Joseph Ratzinger said, "revelation accepted in faith and prayer". In this work Helmut Hoping combines the approaches of dogmatic theology and liturgy while examining the Eucharist from a historical and systematic perspective. This new English translation of the second German edition of this major work, revised and expanded, includes a comparative analysis of the Second Eucharistic Prayer and a chapter on the theology of the words of institution.

Communicative Figurations

The history of belief, piety, and theology (Frömmigkeitsgeschichte) has long stood in the center of Erlangen church historian Berndt Hamm's research interest. Europa! Europa?

This collection contains twenty-one thought-provoking essays on the controversies surrounding the moral and legal distinctions between euthanasia and "letting die." Since public awareness of this issue has increased this second edition includes nine entirely new essays which bring the treatment of the subject up-to-date. The urgency of this issue can be gauged in recent developments such as the legalization of physician-assisted suicide in the Netherlands, "how-to" manuals topping the bestseller charts in the United States, and the many headlines devoted to Dr. Jack Kevorkian, who has assisted dozens of patients to die. The essays address the range of questions involved in this issue pertaining especially to the fields of medical ethics, public policymaking, and social philosophy. The discussions consider the decisions facing medical and public policymakers, how those decisions will affect the elderly and terminally ill, and the medical and legal ramifications for patients in a permanently vegetative state, as well as issues of parent/infant rights. The book is divided into two sections. The first, "Euthanasia and the Termination of Life-Prolonging Treatment" includes an examination of the 1976 Karen Quinlan Supreme Court decision and selections from the 1990 Supreme Court decision in the case of Nancy Cruzan. Featured are articles by law professor George Fletcher and philosophers Michael Tooley, James Rachels, and Bonnie Steinbock, with new articles by Rachels, and Thomas Sullivan. The second section, "Philosophical Considerations," probes more deeply into the theoretical issues raised by the killing/letting die controversy, illustrating exceptionally well the dispute between two rival theories of ethics, consequentialism and deontology. It also includes a corpus of the standard thought on the debate by Jonathan Bennet, Daniel Dinello, Jeffrie Murphy, John Harris, Philipa Foot, Richard Trammell, and N. Ann Davis, and adds articles new to this edition by Bennett, Foot, Warren Quinn, Jeff McMahan, and Judith Lichtenberg.
