The Anthropology of Citizenship

A major realignment is taking place in the way we understand the state in Indonesia. The authors are by no means in agreement with one another as to where the answers might lie. All are aware of the much-wanted differences that good ethnography can make in explaining the human sciences and philosophy. The contributors show a continued commitment to ethnography as a profoundly radical intellectual endeavor that goes to the very roots of inquiry into what it is to be human, and, to anthropology as a comparative project that should be central to any attempt to understand who we are.

The Challenge of Epistemology

Politics is all about power, and power--its composition, creation, and use--pervades this unique and clearly written assessment of the paradigms by which anthropologists explain and understand political phenomena. In Political Anthropology, Donald V. Kurtz examines how anthropologists think about politics, political organizations, and problems fundamental to political anthropology. Power Relations and State Formation

This volume offers a new perspective on social dynamics and culture change in the North Central European Plains (NCEP) from 600 to 900 CE. It discusses long-term causal processes leading to the formation of state at the fringes of the Merovingian and Frankish Kingdoms, the Carolingian and the Holy Roman Empire, the Scandinavian Kingdoms, the Czech Kingdom, and the Kingdom of Rus. The central problem addressed is how to account for and explain the transition from noncomplex to supra-tribal polities between 600 and 900 CE. The examined evidence shows that a very basic community-level management of common pool resources seems a successful strategy to manage short term risk and may lead to sustainable higher level political organization. In conclusion it present a models of social dynamics of the NCEP, 600-900 CE that suggests that the state formation process was an outcome of spontaneous processes and deterministic factors occurring within a period of approximately 400 years, of which the last two hundred years (800-900 CE) were the most critical. In a broader context, the point discussed is that decisions with short-term goals have long-term consequences.

Methodological Approaches to Societies in Transformation

Is war necessary? In Peace and War prominent anthropologists and other social scientists explore the cultural and social factors leading to war. They analyze the covert causes of war from a cross-cultural perspective: ideologies that dispose people to war; underlying patterns of social relationships that help institutionalize war; and the cultural systems of military establishments. Overt causes of war—environmental factors like the control of scarce resources, advantageous territories, and technologies, or promoting the welfare of people "like" oneself—are also considered. The authors examine anthropologists' role in policy formation—how their theories on the nature of culture and society help those who deal with global problems on a day-to-day basis. They argue that both covert and overt mechanisms are pushing the world closer to a devastating war and offer strategies to weaken the effects of these mechanisms. This anthropological and historical analysis of the causes of war is a valuable resource for those studying war and those trying to understand the place of social science in framing pacific options.

Origins of the State

This is the first study of Europe post-1989 from an anthropological perspective. Thirteen distinguished authors examine the social, cultural and political implications of European integration with particular emphasis on changing European identities, concepts of citizenship and levels of participation. Their aim is to suggest an agenda for future research capable of addressing developing trends in contemporary Europe. The book is divided into two parts. The first deals with major theoretical issues that have characterized the anthropological study of Europe and includes a detailed introductory chapter which charts the history of anthropology in Europe and considers the prospects for an anthropology of Europe. This is followed by key themes in the study of European society and culture including kinship, gender, nationalism, immigration and changing patterns of production. The second section develops these themes further using different theoretical perspectives to explain complex issues such as nationalism, ethnic identities, and sectarian conflicts. Nine case studies cover a wide range of contemporary topics including European integration and Irish nationalism, the transmission of ethnic identity, and identity and conflict in the former Yugoslavia and post-colonial Gibraltar. Peace and War

This book explores choice behavior as constrained by culture, biology, and psychoanalytic processes in a variety of ethnographic contexts in Southeast Asia, Oceania, and Africa—the arena in which the

controversy between Derek Freeman and anthropologist Margaret Mead's ideas of culture first developed. It also examines the interface between a nomothetic anthropology and a hermeneutic, idiographic anthropology, raising the critical question as to how ethnographic "knowledge" of another culture is achieved and transmitted to others. Freeman rejects an exclusive reliance on either culture or biology as key to explaining human behavior, proposing instead an interactionist paradigm. Fundamental to this paradigm is choice behavior, which is intrinsic to our biology and basic to the formation of culture: for cultures are the accumulation of socially sanctioned past choices. However, the greater the freedom to choose, the greater the scope for good or bad, and the greater the need for ethics, rules, and laws for defining prohibited alternatives. Choice and Morality investigates these themes. Its authors examine the emergent nature of social reality as a result of choice behavior and illustrate the complexity of Freeman's theoretical position.

The Anthropology of Europe

How and why people develop, maintain, and change cultural boundaries through time are central issues in the social and behavioral sciences in generaland anthropological archaeology in particular. What factors influence people to imitate or deviate from the behaviors of other group members? How are social group boundaries produced, perpetuated, and altered by the cumulative outcomeof these decisions? Answering these questions is fundamental to understanding cultural persistence and change. The chapters included in this stimulating, multifaceted book address these questions. Working in several subdisciplines, contributors report on research in the areas of cultural boundaries, cultural transmission, and the socially organized nature of learning. Boundaries are found not only within and between the societies in these studies but also within and between the communities of scholars who study them. To break down these boundaries, this volume includes scholars who use multiple theoretical perspectives, including practice theory and evolutionary traditions, which are sometimes complementary and occasionally clashing. Geographic coverage ranges from the indigenous Americas to Africa, the Near East, and South Asia, and the time frame extends from the prehistoric or precontact to colonial periods and up to the ethnographic present. Contributors include leading scholars from the United States, Canada, the United Kingdom, and Europe. Together, they employ archaeological, ethnographic, ethnoarchaeological, experimental, and simulation data to link micro-scale processes of cultural transmission to macro-scale processes of social group boundary formation, continuity, and change.

Anthropology and Cultural Studies

In the third edition of this important and influential book, Michael Herzfeld revisits the idea of 'cultural intimacy'. The chapters examine a range of topics touching on the relationship between state and citizen, and the notion of 'national character'. Herzfeld provides a developed theoretical framework and additional clarification of core concepts such as disemia, social poetics and structural nostalgia. There is new material drawn from regions such as Thailand and China, and further consideration of religious intimacy and its impact on cities. The book improves our understanding of how states, societies and institutions function and illustrates the relevance of anthropology to contemporary issues such as globalization, censorship, ethnic conflict and nationalism.

Choice and Morality in Anthropological Perspective

Every year, leading social anthropologists meet to debate a motion at the heart of current theoretical developments in their subject and this book includes the first six of these debates, spanning the period from 1988 to 1993. Each debate has four principal speakers: one to propose the motion, another to oppose it, and two seconders. The first debate addresses the disciplinary character of social anthropology: can it be regarded as a science, and if so, is it able to establish general propositions about human culture and social life? The second examines the concept of society, and in the third debate the spotlight is turned on the role of culture in people's perception of their environments. The fourth debate focuses on the place of language in the formation of culture. The fifth takes up the question of how we view the past in relation to the present. Finally, in the sixth debate, the concern is with the cross-cultural applicability of the concept of aesthetics. With its unique debate format, Key Debates in Anthropology addresses issues that are currently at the top of the theoretical agenda, which register the pulse of contemporary thinking in social anthropology. It will be of value to students who are not

only introduced to the different sides of every argument, but are challenged to join in and to develop informed positions of their own.
