Seminar paper from the year 2007 in the subject American Studies - Literature, grade: 1,0, University of Hamburg (Anglistik und Amerikanistik), course: Holocaust in American Art, language: English, abstract: My analysis in this paper will begin with a short description of Elie Wiesel's life since it plays an important role in most of his stories, especially in his early works (later he tried to avoid autobiographical similarities). According to Wiesel, he only writes as a witness and because he is a witness; that is why lots of autobiographical information can be found in his stories – even if it becomes less obvious in his later works. Wiesel's main protagonists are mostly similar to the young Elie: they are making or have made comparable experiences before, during, and after the Holocaust; they come from the same little town and live in the same places, such as Paris, New York, and the USA. The characters and the outcome of each story reveal Wiesel's thoughts and opinions. In the second part of this paper, I will investigate Wiesel's understanding of madness. This will clarify the importance of madness for Elie Wiesel and it will show that, for Wiesel, madness is much more than just a mental disorder in the common sense. Having given some insight into Wiesel's past and in his comprehension of madness, I will turn to the actual analysis of the four novels. I will examine the madmen, madwomen, and other occurrences of madness in each novel, and interpret my results regarding their respective function. In my conclusion, I will show that there are several functions of madness in Wiesel's novels: he wants to show us that in our insane world faith, even if it sometimes seems like sheer madness too, is important to survive and to overcome insanity.

The Holocaust marks a decisive moment in modern suffering in which it becomes almost impossible to find meaning or redemption in the experience. In this study, C. Fred Alford offers a new and thoughtful examination of the experience of suffering. Moving from the Book of Job, an account of meaningful suffering in a God-drenched world, to the work of Primo Levi, who attempted to find meaning in the Holocaust through absolute clarity of insight, he concludes that neither strategy works well in today's world. More effective are the day-to-day coping practices of some survivors. Drawing on testimonies of survivors from the Fortunoff Video Archives, Alford also applies the work of Julia Kristeva and the psychoanalyst Donald Winnicott to his examination of a topic that has been and continues to be central to human experience.

After the Holocaust

This qualitative journey explores how literature informs and challenges my understanding of teaching and learning. Insights, questions, and conflicts are revealed through a series of essays in which my evolving teacher identity is illuminated through literature and imagination. Hopefully reading this portrayal of literature, which has been a source of educational insight and imagination for me, will be of use to other educators as they reflect on their own teaching. The primary works of literature used to facilitate this journey are: *The Red Badge of Courage* (1895), *Les Misérables* (1862), and *American Idiot* (2004); *Light in August* (1932), *Seinfeld* scripts (1991-98), and *Frankenstein* (1818); and *The Odyssey*, *Night* (1960), and *The Souls of Black Folk* (1903). By delving beneath my exterior 'teacher mask,' a collage of images, anecdotes, reflections, aspirations, and fears is exposed. As a resource for pre-service teachers or a reflective exercise for veteran teachers, this study aims to benefit educators by providing a new pathway through which to better understand their intrinsic identities as teachers. Each chapter concludes with "Recommendations for Reflection" that readers are encouraged to consider individually and/or collectively. The spirit of daydreams allows me to integrate literature, autobiography, and imagination through inventive and inspired discourses with literary figures, using authentic quotations as content for original commentaries that further examine the intrinsic nature of teacher identity. My hope is that this journey will inspire other educators to further reflect on realities and possibilities of what it means to be a teacher.

In his testimony on his survival in Auschwitz Primo Levi said "our language lacks words to express this offense, the demolition of a man". If language, if any language, lacks the words to express the experience of the concentration camps, how does one write the unspeakable? How can it then be translated? The limits of representation and translation seem to be closely linked when it comes to writing about the Holocaust – whether as fiction, memoir, testimony – a phenomenon the current study examines. While there is a spate of literature about the impossibility to represent the Holocaust, not much has been written on the links between translation in its specific linguistic sense, translation studies, and the Holocaust, a niche this volume aims to fill.
