PERFORMANCE

REACT If you are involved in a conflict, one of the best ways to prevent further escalation is to react equivalently to the other party and not overreact.

DE-ESCALATION As a manager, you can reduce conflict escalation by modeling de-escalation processes, and by setting and enforcing limits on conflict escalation.

JUSTICE After a conflict is resolved, it is important to reestablish a sense of justice and trust among the parties.
