A lawyer who represents a corporation may encounter specific ethical questions regarding how his duty to the corporation should be carried out

Attending to the details and schedules needed to assure the matter is handled without harm to the client's interests

Gathering sufficient facts regarding the client's problem

Developing a strategy for solving the client's legal problems

Still, diligence and zeal do not require the lawyer to press for every possible advantage for their client Nor does it mean that a lawyer must employ offensive tactics, or refrain from treating others involved in the legal process with courtesy and respect

All of these decisions should be done in consultation with the lawyer, but the client has the final say Confidentiality

The duty not to reveal information includes any information that could reasonably lead to the discovery of such information

The privilege protects communications between a lawyer and a client, communicated outside of the presence of third parties, which are made for the purpose of obtaining legal assistance or advice
