Copyrights . Give the owner the exclusive right to reproduce and sell an artistic or published work. Granted for the life of the creator plus a specified number of years, commonly 70 years, Capitalize costs of acquiring and defending it Amortized to expense over useful life.

Word, phrase, or symbol that identifies a particular enterprise or product. Coca-Cola, hp and apple, Dell Legal protection for specified number of years, commonly 20 years. Protection may be renewal indefinitely . Capitalize cost of acquisition • No amortization

Goodwill Includes exceptional management, desirable location good customer relations, skilled employees, high-quality products, etc. Only recorded when an entire business is purchased. Goodwill is recorded as the excess of cost over the fair value of the net assets acquired. • Internally created goodwill should not be capitalized. • Not amortized

Illustration: Laser Scanner Ltd. spent NT\$1 million on research and NT\$2 million on development of new products. Of the NT\$2 million in development costs NT\$500,000 was incurred prior to technological feasibility and NT\$1,500,000 was incurred after technological feasibility had been demonstrated.
