Natural Law and the Origin of Political Economy

Samuel Pufendorf's work on natural law and political economy was extensive and has been cited by several important figures in the history of economic thought. Yet his name is rarely mentioned in textbooks on the history of economic thought, the history of political science or the history of philosophy. In this unprecedented study, Arild Sæther sheds new light both on Pufendorf's own life and work, as well as his influence on his contemporaries and on later scholars. The book ends with a discussion of the concept of administration, as we find it in the writings of Saint-Simon, which is seen as a point of transition to the discussion of themes of bureaucracy, technocracy and managerialism.

It has played a great part in the collapse of communism. Suvanto's book was first published in Finnish in 1994 and it was chosen as the best historical book in Finland in that year.

Conservatism from the French Revolution to the 1990s

The concept of customary international law, although differently formulated, is already present in early modern European debates on natural law and the law of nations. However, no scholarly monograph has, until now, addressed the relationship between custom and the European natural law and ius gentium tradition. This book tells that neglected story, and offers a solid conceptual framework to contextualize

and understand the 'problematic of custom', namely how to identify its normative content. Natural law doctrines, and the different ways in which they help construct human reason, provided custom with such normative content. This normative content consists of a set of fundamental moral values that help identify the status of custom as either a fundamental feature or an original source of ius gentium. This book explores what cultural values and practices facilitated the emergence of custom and rendered it into as a source of the law of nations, and how they did so. Two crucial issues form the core of the book's analysis. Firstly, it qualifies the nature of the interrelation between natural law and ius gentium, explaining why it matters in relation to our understanding of the idea of custom. Second, the book claims that the process of custom formation as a source of law calls into question the role of the authority of history. The interpretation of the past through this approach can thus be described as one of 'invention'.

The Invention of Custom

"This is an edition of two manuscripts with notes taken during Samuel Pufendorf's teaching at the University of Lund in the early 1670s. The shorter manuscript consists of annotations from lectures on De jure naturae et gentium, the lengthier renders notes taken during lectures on De officio hominis et civis. The texts show Pufendorf's doctrine at the pedagogic level, as it was presented to students immediately after his books were published. The effect of that is that natural law is imbedded in religion; Biblical references are numerous compared to in the printed books. Still, many comments reflect Pufendorf's conflict with local adversaries in Lund and with Lutheran theologians in Germany. The main message, however, is that natural law, i.e. Pufendorf, should replace Aristotle as foundation for the teaching of moral philosophy"--Title page verso.

Jahrhunderts zeigt diese vergleichende, literaturund denkgeschichtliche Untersuchung, daß die Beschreibung Webers zwar zutrifft, aber zu kurz greift: Wenn reformierte Gelehrte wie der Naturrechtler Jean Barbeyrac, der Prediger-Philosoph Jean Henri Samuel Formey, der Mathematiker Jean Pierre de Crousaz und der Mediziner-Dichter Albrecht von Haller "rationalen" Morallehren (Hugo Grotius, Samuel Pufendorf, Christian Wolff) zuneigten, dann bestand ihre Leistung darin, diese "empirisch" zu prüfen, die "Bedrohung" durch die Skepsis abzuwehren und das Ergebnis in "angenehmer Form" zu verbreiten. Sie pflegten den Austausch mit Gelehrten unterschiedlicher Herkunft und Anschauung, traten für Toleranz und für die Vereinigung der protestantischen Kirchen ein. Deutsche Autoren wie Johann Christoph und Luise Adelgunde Victoria Gottsched teilten ihre Anliegen und folgten dem französisch-reformierten Vorbild. Christoph Martin Wieland aber kritisierte die "rationalen" Morallehren im philosophischen Roman - um sie als eine Denkmöglichkeit zu erhalten. Denn die "empirische" und gemäßigte Aufklärung betrachtete sich bereits als durch radikale Philosophien gefährdet. In der Literatur suchte sie eine Zuflucht.

Iselin Contra Rousseau

Samuel Pufendorf's Of the Nature and Qualification of Religion (published in Latin in 1687) is a major work on the separation of politics and religion. Written in response to the revocation of the Edict of Nantes by the French king Louis XIV, Pufendorf contests the right of the sovereign to control the religion of his subjects, because state and religion pursue wholly different ends. He concludes that, when

rulers transgress their bounds, subjects have a right to defend their religion, even by the force of arms. Pufendorf's ideas on natural law and toleration were highly influential in both Europe and the British Isles. Samuel Pufendorf (1632-1694) taught natural law and was court historian in both Germany and Sweden. Simone Zurbuchen is Professor of Philosophy at the University of Fribourg, Switzerland.

Samuel Pufendorf's On the Natural State of Men

The 1st part of the volume engages with the theme of inclusion and exclusion in the history of ideas from different perspectives. The 2nd part of the volume discusses debates on natural law, human nature and political economy in early-modern Europe. Its contributions explore the sorts of political and moral visions that were relevant in post-Hobbesian moral philosophy and the development of economic thought.

The Whole Duty of Man According to the Law of Nature

Die Institution der Sklaverei ist älter als das Christentum. Die Forschung hat immer wieder auf den humanisierenden Einfluss der christlichen Erlösungsreligion aufmerksam gemacht, in der auch Sklaven als Menschen in den Blick genommen wurden. Doch auch unter christlichen Vorzeichen existierte Sklaverei weiter und gehörte noch bis ins 19. Jahrhundert hinein zur Realität christlicher (und muslimischer) Gesellschaften im Mittelmeerraum. Wie ließ sich diese Praxis mit dem Christentum vereinbaren, das jeden Menschen als Ebenbild Gottes versteht? Die acht Beiträge dieses Sammelbandes sind aus einem von der DFG geförderten gleichnamigen Forschungsprojekt hervorgegangen. Sie widmen sich dieser Frage erstmals in einem theologiegeschichtlichen Zugriff. So werden Humanisierungstendenzen und ihre Grenzen bei christlichen Autoren vom 2. bis zum 17. Jahrhundert (u.a. Tatian, Basilius von Caesarea, Johannes Chrysostomus, Thomas von Aguin, Martin Luther, Cornelius a Lapide) und im Mönchtum herausgearbeitet. Dabei lassen sich neue Einsichten in Legitimationsund Bewältigungsstrategien sowie Rezeptionsprozesse gewinnen. The institution of slavery pre-dates Christianity. Scholarship has often drawn attention to the humanising influence of the Christian religion of salvation, which views slaves too as human. But slavery continued to exist in Christian contexts and, until the 19th century, formed part of the reality of Christian (and Muslim) societies in the Mediterranean region. How could this practice be reconciled with Christianity, which sees all people as made in God's image? The eight contributions to this volume have their origins in a DFG-sponsored project of the same name. For the first time they approach this question from the perspective of the history of theology, examining humanising tendencies and their limits in the work of Christian authors from the 2nd to the 17th century (including Tatian, Basil of Caesarea, John Chrysostom, Thomas Aquinas, Martin Luther and Cornelius a Lapide) and in monasticism. This approach offers new insights into strategies of legitimisation and coping, and into processes of reception.

Of the Law of Natur and Nations

In den Jahrzehnten um 1700 entfaltet das profane Naturrecht eine Wirksamkeit, die sich kaum überschätzen läßt; zunächst im Gebiet der praktischen Philosophie, aber auch weit darüber hinaus – sie reicht von der Herrschaftsdoktrin des Absolutismus bis in die Umgangslehren des Alltags. Das von S. Pufendorf und C. Thomasius ausgearbeitete und rasch popularisierte Naturrecht hat die Orientierungsfunktionen einer bis dahin religiös geprägten Sozialethik übernommen und einen kaum zu überschätzenden Beitrag zu der neuen gesellschaftlichen und anthropologischen Selbstdeutung des Menschen im 18. Jahrhundert geleistet. Die in seiner Tradition formulierten Begriffe – Geselligkeit, vernünftige Selbstliebe etc. – bilden den Leitfaden einer historisch-semantischen Untersuchung der Quellen, die zeigt, wie die naturrechtliche Pflichtenlehre Kommunikationsmuster in verschiedenen Gattungen der moraldidaktischen Literatur (Moralische Wochenschriften, Satire, Lehrdichtung, Roman) zwischen 1670 und 1770 geprägt hat. Damit entsteht ein kategorialer Bezugsrahmen, in dem vorhandene Konzeptionen der Literaturgeschichtsschreibung überprüft werden können.

Reformierte Morallehren und deutsche Literatur von Jean Barbeyrac bis Christoph Martin Wieland

Samuel Pufendorf (1632–1694) hat in "De jure naturae et gentium", dem wichtigsten Lehrbuch des Naturrechts seiner Epoche, seine Doktrinen von der persona moralis und von der Soziabilität des Menschen ausführlich dargestellt und sie philosophisch, theologisch und historisch begründet. Diese Theorien, die für die Sittlichkeit der bürgerlichen Gesellschaft in der Frühaufklärung grundlegend sind, werden – nicht ohne Spannung – eingebaut in eine Staatslehre, die am Konzept der Souveränität ausgerichtet ist. Es gab vor Immanuel Kant in Deutschland keinen Juristen und Philosophen, der politisch zentrale Begriffe wie Natur- und Menschenrecht, moralische Person und Toleranz so gründlich und so wirkmächtig bestimmt hat. An Pufendorf zu erinnern, stärkt die eigenen Traditionen. Rechtsstaatlichkeit muss so nicht als Belehrung von außen, sondern kann als autochthone, und somit als natürliche Rechtsform aufgefasst werden – es gibt keine stärkeren Argumente für die Stabilität des Rechts, als wenn Naturrecht, regionales Recht und geschichtliches Recht zusammenfallen. Frank Böhling legt in seinem Materialienband neben detailreichen Beiträgen zu Pufendorfs Biographie nun den Stellenkommentar zu den von ihm edierten acht Büchern dieses Werkes (Bände 4.1 und 4.2 unserer Ausgabe) vor. Ergänzt durch ausführliche Indizees.
