In addition to the destruction of the alternate water injection arrangement, the capability to vent the containment in Unit 2 was also lost.

Following the events in Units 2, all personnel, except essential workers required for monitoring and emergency response, were instructed by the Site Superintendent to go to a radiologically safe location.

At this time sea water was swapped for borated fresh water in the cooling efforts of the reactors, meaning the situation was gradually coming back under control.
