Family Care and Social Capital: Transitions in Informal Care

Becoming a caregiver is increasingly an inevitable experience for many people and, therefore, a likely life transition. Drawing on research and personal experiences of working with family caregivers, this book examines a range of family caregiving situations from across the life course. It seeks to capture the dynamics of caregiving in a number of common situations: caregiving during infancy, for adults who acquire a disability through accidents or illness, for older people with age-related issues, and caregiving by children and adolescent carers and grandparent carers. In drawing attention to key moments of vulnerability faced by family and informal caregivers, and by suggesting how to assist 'reconnection' at these moments, the book provides a guide for those working in the area of health, disability and care. Informal care is conceptualised as occurring with the context of personal interrelationships, these being nested within wider kin networks and linked with wider professional formal care networks. Informal care is seen both as an expression of social capital and as an activity that builds social capital. It is an indicator of resources of mutual support within social networks, and it has the effect of adding to the stock of social resources. The book makes a case, therefore, for facilitating the development of social capital by strengthening the capacity of informal caregivers and caregiver groups, and by improving the linkages with formal care organisations.

This is a qualitative study into the experiences of parents of disabled children in Iceland in the period 1974-2007. Hardly any formal support was available to these families in 1974. In 2007 the formal support system shaped by social and educational policy reflected almost "the state of the art". The study gives voice to the experiences of parents in seventy five extraordinary families in pursuit of ordinary lives.

It explores their access to social capital and its impact. The findings resonate to some extent with less comprehensive studies in the Nordic countries, the Anglo-Saxon world and Northern Europe. The unique contribution of this book is that it specifically lifts the fathers' voices independently of the mothers'; it spans the period of 33 years when the welfare system and inclusive education was put in place; and it uses social capital theory in analysing support, concluding that social capital can be built as well as eroded or destroyed. Response-ability in the era of AIDS

The recent explosion in population aging across the globe represents one of the most remarkable demographic changes in human history. There is much concern about population aging and its consequences for nations, for governments, and for individuals. It has often been noted that population aging will inevitably affect the economic stability of most countries and the policies of most state governments. What is less obvious, but equally important, is that population aging will profoundly affect families. Who will care for the growing numbers of tomorrow's very old members of societies? Will it be state governments? The aged themselves? Their families? The purpose of this volume is to examine consequences of global aging for families and intergenerational support, and for nations as they plan for the future. Four remarkable social changes during the past fifty years are highlighted: (1) Extension of the life course: A generation has been added to the average span of life over the past century; (2) Changes in the age structures of nations: Most nations today have many more elders, and many fewer children, than fifty years ago; (3) Changes in family structures and relationships: Some of these differences are the result of trends in family structure, notably higher divorce rates and the higher incidence of childbearing to single parents; (4) Changes in governmental responsibilities: In the last decade, governmental responsibility appears to have slowed or reversed as states reduce welfare expenditures. How will families respond to twenty-first-century problems associated with population aging? Will families indeed be important in the twenty-first century, or will kinship and the obligations across generations become increasingly irrelevant, replaced by "personal communities"? This volume goes a considerable distance to answer these critical issues for the twenty-first century. Vern L. Bengtson is an AARP/University Chair in Gerontology and Professor of Sociology, University of Southern California. Ariela Lowenstein is associate professor and head, Department of Aging Studies, University of Haifa, Israel.

loneliness of older urban Chinese adults. This book targets at a broad audience with knowledge in social gerontology and social work with older adults. It will appeal to academic researchers, undergraduate and graduate students, policymakers, and social workers who have interests in social capital and mental well-being in later life, and the impacts of COVID-19 on the well-being of older adults.

The Wiley Blackwell Companion to the Sociology of Families

Meeting the needs of children at the same time as promoting family life is more than a question of resources: it needs a culture change in social services: a rediscovery and a modernization of the social action and community development traditions in social work. In Social Action with Children and Families the authors argue that ways must be found to work together to promote environments in which children can flourish, and to develop forms of public life which are friendly to children and their parents. Recent changes in child care systems have put more pressures on those working in it. Enhancing the Well-being of Children and Families through Effective Interventions

Effective Family Support

The concept of 'social capital' is considered through a number of theoretical and empirical studies which discuss its analytical foundations, as well as institutional and statistical analyses of the concept. It includes the classic 1987 article by the late James Coleman, 'Social Capital in the Creation of Human Capital', which formed the basis for the development of social capital as an organising concept in the social sciences.

Families and Child Health

The text addresses the impact and effectiveness of family centres in supporting children, families and communities.
