Euclidean and Non-Euclidean Geometries

This is the second of three volumes that, together, give an exposition of the mathematics of grades 9–12 that is simultaneously mathematically correct and grade-level appropriate. The volumes are consistent with CCSSM (Common Core State Standards for Mathematics) and aim at presenting the mathematics of K–12 as a totally transparent subject. The first part of this volume is devoted to the study of standard algebra topics: quadratic functions, graphs of equations of degree 2 in two variables, polynomials, exponentials and logarithms, complex numbers and the fundamental theorem of algebra, and the binomial theorem. Having translations and the concept of similarity at our disposal enables us to clarify the study of quadratic functions by concentrating on their graphs, the same way the study of linear functions is greatly clarified by knowing that their graphs are lines. We also introduce the concept of formal algebra in the study of polynomials with complex coefficients. The last three chapters in this volume complete the systematic exposition of high school geometry that is consistent with CCSSM. These chapters treat the geometry of the triangle and the circle, ruler and compass constructions, and a general discussion of axiomatic systems, including non-Euclidean geometry and the celebrated work of Hilbert on the foundations. This book should be useful for current and future teachers of K–12 mathematics, as well as for some high school students and for education professionals.

Instructor's Manual for Euclidean and Non-Euclidean Geometries

In this monograph, the authors present a modern development of Euclidean geometry from independent axioms, using up-to-date language and providing detailed proofs. The axioms for incidence, betweenness, and plane separation are close to those of Hilbert. This is the only axiomatic treatment of Euclidean geometry that uses axioms not involving metric notions and that explores congruence and isometries by means of reflection mappings. The authors present thirteen axioms in sequence, proving as many theorems as possible at each stage and, in the process, building up subgeometries, most notably the Pasch and neutral geometries. Standard topics such as the congruence theorems for triangles, embedding the real numbers in a line, and coordinatization of the plane are included, as well as theorems of Pythagoras, Desargues, Pappas, Menelaus, and Ceva. The final chapter covers consistency and independence of axioms, as well as independence of definition properties. There are over 300 exercises; solutions to many of these, including all that are needed for this development, are available online at the homepage for the book at www.springer.com. Supplementary material is available online covering construction of complex numbers, arc length, the circular functions, angle measure, and the polygonal form of the Jordan Curve theorem. Euclidean Geometry and Its Subgeometries is intended for advanced students and mature mathematicians, but the proofs are thoroughly worked out to make it accessible to undergraduate students as well. It can be regarded as a completion, updating, and expansion of Hilbert's work, filling a gap in the existing literature.

Algebra and Geometry

This book contains carefully revised and expanded versions of eight courses that were presented at the University of Strasbourg during two geometry master classes in 2008 and 2009. The aim of the master classes was to give fifth-year students and Ph.D. students in mathematics the opportunity to learn new topics that lead directly to the current research in geometry and topology. The courses were taught by leading experts. The subjects treated include hyperbolic geometry, three-manifold topology, representation theory of fundamental groups of surfaces and of three-manifolds, dynamics on the hyperbolic plane with applications to number theory, Riemann surfaces, Teichmüller theory, Lie groups, and asymptotic geometry. The text is aimed at graduate students and research mathematicians. It can also be used as a reference book and as a textbook for short courses on geometry.

Euclidean Geometry and its Subgeometries

Lobachevsky wrote Pangeometry in 1855, the year before his death. This memoir is a resume of his work on non-Euclidean geometry and its applications and can be considered his clearest account on the subject. It is also the conclusion of his life's work and the last attempt he made to acquire recognition.

The treatise contains basic ideas of hyperbolic geometry, including the trigonometric formulae, the techniques of computation of arc length, of area and of volume, with concrete examples. It also deals with the applications of hyperbolic geometry to the computation of new definite integrals. The techniques are different from those found in most modern books on hyperbolic geometry since they do not use models. Besides its historical importance, Lobachevsky's *Pangeometry* is a beautiful work, written in a simple and condensed style. The material that it contains is still very alive, and reading this book will be most useful for researchers and for students in geometry and in the history of science. It can be used as a textbook, as a sourcebook, and as a repository of inspiration. The present edition provides the first complete English translation of *Pangeometry* available in print. It contains facsimiles of both the Russian and the French original versions. The translation is accompanied by notes, followed by a biography of Lobachevsky and an extensive commentary.

Pangeometry

Geometry: The Line and the Circle is an undergraduate text with a strong narrative that is written at the appropriate level of rigor for an upper-level survey or axiomatic course in geometry. Starting with Euclid's *Elements*, the book connects topics in Euclidean and non-Euclidean geometry in an intentional and meaningful way, with historical context. The line and the circle are the principal characters driving the narrative. In every geometry considered—which include spherical, hyperbolic, and taxicab, as well as finite affine and projective geometries—these two objects are analyzed and highlighted. Along the way, the reader contemplates fundamental questions such as: What is a straight line? What does parallel mean? What is distance? What is area? There is a strong focus on axiomatic structures throughout the text. While Euclid is a constant inspiration and the *Elements* is repeatedly revisited with substantial coverage of Books I, II, III, IV, and VI, non-Euclidean geometries are introduced very early to give the reader perspective on questions of axiomatics. Rounding out the thorough coverage of axiomatics are concluding chapters on transformations and constructibility. The book is compulsively readable with great attention paid to the historical narrative and hundreds of attractive problems.

Geometry: The Line and the Circle

Geometry Illuminated is an introduction to geometry in the plane, both Euclidean and hyperbolic. It is designed to be used in an undergraduate course on geometry, and as such, its target audience is undergraduate math majors. However, much of it should be readable by anyone who is comfortable with the language of mathematical proof. Throughout, the goal is to develop the material patiently. One of

the more appealing aspects of geometry is that it is a very "visual" subject. This book hopes to take full advantage of that, with an extensive use of illustrations as guides. *Geometry Illuminated* is divided into four principal parts. Part 1 develops neutral geometry in the style of Hilbert, including a discussion of the construction of measure in that system, ultimately building up to the Saccheri-Legendre Theorem. Part 2 provides a glimpse of classical Euclidean geometry, with an emphasis on concurrence results, such as the nine-point circle. Part 3 studies transformations of the Euclidean plane, beginning with isometries and ending with inversion, with applications and a discussion of area in between. Part 4 is dedicated to the development of the Poincaré disk model, and the study of geometry within that model. While this material is traditional, *Geometry Illuminated* does bring together topics that are generally not found in a book at this level. Most notably, it explicitly computes parametric equations for the pseudosphere and its geodesics. It focuses less on the nature of axiomatic systems for geometry, but emphasizes rather the logical development of geometry within such a system. It also includes sections dealing with trilinear and barycentric coordinates, theorems that can be proved using inversion, and Euclidean and hyperbolic tilings.

Classical Geometry

The long-awaited new edition of a groundbreaking work on the impact of alternative concepts of space on modern art. In this groundbreaking study, first published in 1983 and unavailable for over a decade, Linda Dalrymple Henderson demonstrates that two concepts of space beyond immediate perception—the curved spaces of non-Euclidean geometry and, most important, a higher, fourth dimension of space—were central to the development of modern art. The possibility of a spatial fourth dimension suggested that our world might be merely a shadow or section of a higher dimensional existence. That iconoclastic idea encouraged radical innovation by a variety of early twentieth-century artists, ranging from French Cubists, Italian Futurists, and Marcel Duchamp, to Max Weber, Kazimir Malevich, and the artists of De Stijl and Surrealism. In an extensive new Reintroduction, Henderson surveys the impact of interest in higher dimensions of space in art and culture from the 1950s to 2000. Although largely eclipsed by relativity theory beginning in the 1920s, the spatial fourth dimension experienced a resurgence during the later 1950s and 1960s. In a remarkable turn of events, it has returned as an important theme in contemporary culture in the wake of the emergence in the 1980s of both string theory in physics (with its ten- or eleven-dimensional universes) and computer graphics. Henderson demonstrates the importance of this new conception of space for figures ranging from Buckminster Fuller, Robert Smithson, and the Park Place Gallery group in the 1960s to Tony Robbin and digital architect Marcos Novak.

Introduction to Non-Euclidean Geometry

This volume is a collection of essays on complex symmetries. It is curated, emphasizing the analysis of the symmetries, not the various phenomena that display those symmetries themselves. With this, the volume provides insight to nonspecialist readers into how individual simple symmetries constitute complex symmetry. The authors and the topics cover many different disciplines in various sciences and arts. Simple symmetries, such as reflection, rotation, translation, similitude, and a few other simple manifestations of the phenomenon, are all around, and we are aware of them in our everyday lives. These include physical symmetries, functional (meaning not morphological) symmetries, such as symmetries in the construction of the genetic code, symmetries in human perception (e.g., in geometry education as well as in constructing physical theories), symmetries in fractal structures and structural morphology, including quasicrystal and fullerene structures in stable bindings and their applications in crystallography and architectural design, as well as color symmetries in the arts. The volume is rounded off with beautiful illustrations and presents a fascinating panorama of this interdisciplinary topic.

Math through the Ages: A Gentle History for Teachers and Others Expanded Second Edition

Geometry was considered until modern times to be a model science. To be developed more geometrico was a seal of quality for any endeavor, whether mathematical or not. In the 17th century, for example, Spinoza set up his Ethics in a more geometrico manner, to emphasize the perfection, certainty, and clarity of his pronouncements. Geometry achieved this status on the heels of Euclid's Elements, in which, for the first time, a theory was built up in an axiomatic-deductive manner. Euclid started with obvious axioms - he called them "common notions" and "postulates" -, statements whose validity raised no doubts in the reader's mind. His propositions followed deductively from those axioms, so that the truth of the axioms was passed on to the propositions by means of purely logical proofs. In this sense, Euclid's geometry consisted of "eternal truths." Given its prominence, Euclid's Elements was also used as a textbook until the 20th Century. Today geometry has lost the central importance it had during earlier centuries, but it still is an important area of mathematics, and is truly fundamental for mathematics from a variety of points of view. The "Introduction to Geometry" by Ewald tries to address some of these points of view, whose significance will be examined in what follows from a historical perspective.

Exploring Geometry

This book is a text for junior, senior, or first-year graduate courses traditionally titled Foundations of Geometry and/or Non Euclidean Geometry. The first 29 chapters are for a semester or year course on the foundations of geometry. The remaining chapters may then be used for either a regular course or independent study courses. Another possibility, which is also especially suited for in-service teachers of high school geometry, is to survey the fundamentals of absolute geometry (Chapters 1 -20) very quickly and begin earnest study with the theory of parallels and isometries (Chapters 21 -30). The text is self-contained, except that the elementary calculus is assumed for some parts of the material on advanced hyperbolic geometry (Chapters 31 -34). There are over 650 exercises, 30 of which are 10-part true-or-false questions. A rigorous ruler-and-protractor axiomatic development of the Euclidean and hyperbolic planes, including the classification of the isometries of these planes, is balanced by the discussion about this development. Models, such as Taxicab Geometry, are used extensively to illustrate theory. Historical aspects and alternatives to the selected axioms are prominent. The classical axiom systems of Euclid and Hilbert are discussed, as are axiom systems for three and four-dimensional absolute geometry and Pieri's system based on rigid motions. The text is divided into three parts. The Introduction (Chapters 1 -4) is to be read as quickly as possible and then used for reference if necessary.
