In early 1869, Harry Wright of the Cincinnati Base Ball Club made an announcement to the sporting press: the Red Stockings would be the first all-professional club in the history of the game. The outcry could be heard in nearly every town in which the sport was played. Wright, however, paid little heed to their protests and went about his business of signing players. By the start of the season he had inked ten players to contracts, with salaries ranging from \$600 to \$1,400 annually. By June of 1870, the Red Stockings had compiled a 90-game winning streak and were recognized as the finest team in the game. How the Red Stockings were formed, who the players were, and why things came to an end are all fully covered in this detailed history.

CIGAR BOX LITHOGRAPHS: The Inside Stories Uncovered is a thought-provoking production exposing its readership to more than 160 vintage cigar boxes manufactured during the late 19th and early 20th centuries. Most convey stunning lithographs that portray prominent historical figures. Such cigar boxes during the 19th century attracted a massive smoking clientele numbering in the millions.... While puffers more than one hundred years ago likely recognized the prominent personalities peering at them from the inside labels of these wooden cigar boxes, those same headlined names, today, are now essentially erased from memory. Lew Wallace (1827- 1905), portrayed in this stunning portrait label, is virtually a forgotten name today. World-famous during his day, he was not only a Major General during the Civil War but became more famous when he wrote what some consider to be the best-selling novel of the 19th century. His *Ben Hur* (see page 34), a novel that was turned into a Hollywood blockbuster winning a record eleven Oscars in 1959, was certainly the most read and the best-known book title during the 20th century, that is, until it was superseded by *Gone with the Wind* in the 1930s. By examining the cartouche to the left of this stunning label portrait, one detects Wallace's role as a General during the Civil War, especially at the Battle of Shiloh. The cartouche to the right of his portrait details his writing studio in Crawfordsville, Indiana. This is where his most famous novel was written. Cigar boxes from the past often became an educational platform inadvertently recording and preserving history. To this day, this nearly 120-year old collectible cigar container whispers its provocative past, that is, providing one takes time out to lift its lid and peer at the lithographic image waiting to be re-discovered or uncovered.... Peer long enough and the box just might whisper its past to you.

Publication

Adoption has been a politically charged subject since the Progressive Era, when it first became an established part of child welfare reform. In *A Home for Every Child*, Patricia Susan Hart looks at how,

when, and why modern adoption practices became a part of child welfare policy. The Washington Children's Home Society (now the Children's Home Society of Washington) was founded in 1896 to place children into adoptive and foster homes as a means of dealing with child abuse, neglect, and homelessness. Hart reveals why birth parents relinquished their children to the Society, how adoptive parents embraced these vulnerable family members, and how the children adjusted to their new homes among strangers. Debates about nature versus nurture, fears about immigration, and anxieties about race and class informed child welfare policy during the Progressive Era. Hart sheds new light on that period of time and the social, cultural, and political factors that affected adopted children, their parents, and administrators of pioneering institutions like the Washington Children's Home Society.

The Red Stockings of Cincinnati

In 1987, the University of Chicago Press published *Primate Societies*, the standard reference in the field of primate behavior for an entire generation of students and scientists. But in the twenty-five years since its publication, new theories and research techniques for studying the Primate order have been developed, debated, and tested, forcing scientists to revise their understanding of our closest living relatives. Intended as a sequel to *Primate Societies*, *The Evolution of Primate Societies* compiles thirty-one chapters that review the current state of knowledge regarding the behavior of nonhuman primates. Chapters are written by the leading authorities in the field and organized around four major adaptive problems primates face as they strive to grow, maintain themselves, and reproduce in the wild. The inclusion of chapters on the behavior of humans at the end of each major section represents one particularly novel aspect of the book, and it will remind readers what we can learn about ourselves through research on nonhuman primates. The final section highlights some of the innovative and cutting-edge research designed to reveal the similarities and differences between nonhuman and human primate cognition. *The Evolution of Primate Societies* will be every bit the landmark publication its predecessor has been.

Parliamentary Papers

As a player, manager, team captain, umpire, owner and league president, Hall of Famer Jim O'Rourke (1851-1918) spoke for the players in the emerging game of baseball. O'Rourke's career paralleled the rise of the game from a regional sport with few strategies to the national pastime. Nicknamed "Orator" for his booming voice and his championing of the rights of professional athletes, he was a driving force in making the sport a profession, bringing respectability to the role of professional baseball player. From contemporary sources, O'Rourke's own correspondence, and player files available through the National Baseball Library, a rounded portrait of Jim O'Rourke emerges. Quick to speak his mind, the outfielder played on nine pennant-winning teams, but his playing career was overshadowed by his work in organizing baseball's first union. After his playing days ended, O'Rourke attempted to establish the Connecticut League, becoming the circuit's president, secretary, and treasury. Though the league failed to fully materialize, his Bridgeport Victors did play several games and were one of the few racially integrated teams--a fact emblematic of O'Rourke's efforts to change the national pastime. In those efforts, he attempted to wrest control of the game from the owners and empower the players. A carefully researched account of O'Rourke's life and career, this biography also provides a behind-the-scenes look at the growth of the national pastime from the Civil War through the deadball era.
