Public Housing

This book explores the often-overlooked positive role of public housing in facilitating social movements and activism. Taking a political, social, and spatial perspective, the author offers Atlanta as a case study. Akira Drake Rodriguez shows that the decline in support for public housing, often touted as a positive (neoliberal) development, has negative consequences for social justice and nascent activism, especially among Black women. Urban revitalization policies target public housing residents by demolishing public housing towers and dispersing poor (Black) residents into new, deconcentrated spaces in the city via housing choice vouchers and other housing-based tools of economic and urban development. Diverging Space for Deviants establishes alternative functions for public housing developments that would necessitate their existence in any city. In addition to providing affordable housing for low-income residents—a necessity as wealth inequality in cities increases—public housing developments function as a necessary political space in the city, one of the last remaining frontiers for citizens to engage in inclusive political activity and make claims on the changing face of the state.

The Politics of Public Housing

Exploring the politics of housing during 1890-1990, this fascinating study examines the interaction not only of national and local politics but also of local factors such as civic culture, key local players, local

discourse and geographical and demographic problems. This book argues that increasingly, tenants acted as consumers of a public service, and it questions the way in which notions of consumerism shaped responses to the housing debate. The politics of housing

The building and management of public housing is often seen as a signal failure of American public policy, but this is a vastly oversimplified view. In Purging the Poorest, Lawrence J. Vale offers a new narrative of the seventy-five-year struggle to house the "deserving poor." In the 1930s, two iconic American cities, Atlanta and Chicago, demolished their slums and established some of this country's first public housing. Six decades later, these same cities also led the way in clearing public housing itself. Vale's groundbreaking history of these "twice-cleared" communities provides unprecedented detail about the development, decline, and redevelopment of two of America's most famous housing projects: Chicago's Cabrini-Green and Atlanta's Techwood /Clark Howell Homes. Vale offers the novel concept of design politics to show how issues of architecture and urbanism are intimately bound up in thinking about policy. Drawing from extensive archival research and in-depth interviews, Vale recalibrates the larger cultural role of public housing, revalues the contributions of public housing residents, and reconsiders the role of design and designers.

Housing Politics in the United Kingdom

Public housing was once an important strand in western housing policies, but is seldom seen as a mainstream policy instrument for the future. In contrast, in many East Asian countries large public housing programs are underway. Behind these generalizations, there are exceptions, too. By including perspectives of scholars from across the world, this book provides new insights into public housing in its various forms. It contains in-depth chapters on public housing in five East Asian countries and six Western countries, together with three comparative overview chapters.

In Defense of Housing

This volume provides a comprehensive analysis of how politics shape housing markets and vice-versa. It demonstrates how housing impacts a variety of social and political phenomenon including populist politics, generational divides, wealth inequality, monetary policy, and the welfare state. Housing and housing markets have important implications for economic stability, public policy, domestic politics and

wealth inequality in Europe and beyond. Yet despite its importance, housing has received relatively little attention in comparative politics scholarship. The contributions within this volume push the scholarship of housing into fresh, innovative directions. The chapters focus on housing's contribution to wealth inequality, how housing constrains governments' policy choices in welfare state reform and how it can strengthen governments' hands in financial regulation. Other contributions reveal the impact of housing on central bankers' motivations for implementing monetary expansion, highlight the generational divide in gaining access to home-ownership, demonstrate how housing-driven wealth inequality steers voters political preferences towards right-wing populism, and explain how housing gradually shifted from being a social right to an object of investment in Europe, even within its most egalitarian states. These contributions cover a diversity of cases in Western and Eastern Europe and theoretical paradigms that will appeal to scholars and policy makers alike. Politics, Planning, and the Public Interest

Originally published in 1988, this book offers the first comprehensive and critical analysis of the privatisation of public housing in Britain. It outlines the historical background to the growth of public housing and the developing political debatea surrounding its disposal. The main emphasis in the book, however, is on the ways in which privatisation in housing links to other key changes in British society. The long trend for British social housing to become a welfare housing sector is related to evidence of growing social polarisation and segregation. Within this overall context, the book explores the uneven spatial and social consequences of the policy.

Bricks in the Wall

Public housing was an integral part of the New Deal, as the federal government funded public works to generate economic activity and offer material support to families made destitute by the Great Depression, and it remained a major element of urban policy in subsequent decades. As chronicled in New Deal Ruins, however, housing policy since the 1990s has turned to the demolition of public housing in favor of subsidized units in mixed-income communities and the use of tenant-based vouchers rather than direct housing subsidies. While these policies, articulated in the HOPE VI program begun in 1992, aimed to improve the social and economic conditions of urban residents, the results have been quite different. As Edward G. Goetz shows, hundreds of thousands of people have been displaced and there has been a loss of more than 250,000 permanently affordable residential units. Goetz offers a critical analysis of the nationwide effort to dismantle public housing by focusing on the impact of policy changes in three cities: Atlanta, Chicago, and New Orleans. Goetz shows how this transformation is related to pressures of gentrification and the enduring influence of race in American cities. African Americans have been disproportionately affected by this policy shift; it is the cities in which public housing is most closely identified with minorities that have been the most aggressive in removing units. Goetz convincingly refutes myths about the supposed failure of public housing. He offers an evidence-based argument for renewed investment in public housing to accompany housing choice initiatives as a model for innovative and equitable housing policy.

The Unseen Politics of Public Housing

Home and care are central aspects of everyday, personal lives, yet they are also shaped by political and economic change. Within a context of austerity, economic restructuring, worsening inequality and resource rationing, policy around and experience of these key areas is shifting. Taking an interdisciplinary and feminist perspective, this book illustrates how economic and political changes affect everyday lives for many families and households in the UK. Setting out both new empirical material and new conceptual terrain, the authors draw on approaches from human geography, social policy, feminist and political theory to explore issues of home and care in times of crisis.

In Defense of Housing

Singapore's successful public housing programme is a source of political legitimacy for the ruling People's Action Party. Beng-Huat Chua accounts for the success of public housing in Singapore and draws out lessons for other nations. Housing in Singapore, he explains in this incisive analysis, is seen neither as a consumer good (as in the US) nor as a social right (as in the social democracies of Europe). The author goes on to look at the ways in which Singapore's planners have dealt with the problems of creating communities in a modern urban environment. He concludes that the success of the public housing programme has done much for Singapore.

Selling the Welfare State

Thousands are homeless, tens of thousands are languishing on social housing waiting lists, even more are unable to afford to rent or buy. Why is our housing system so dysfunctional? Why can it not meet social and affordable housing needs? Home: Why Public Housing is the Answer examines the structural causes of our housing emergency, provides a detailed critique of government housing policy from the 1980s to the present and outlines a comprehensive, practical and radical alternative that would meet the housing needs of the many, not just the few. For three decades Government policy has been marked by an undersupply of social housing and an over-reliance on the private market to meet housing needs. Housing has become a commodity, not a public good. The result is a dysfunctional housing system that is leaving more and more people unable to access appropriate, secure and affordable homes. The answer, as argued in this transformative new book, lies in establishing a Constitutional right to housing, large scale investment in a new model of public housing to meet social and affordable housing need, real reform of the private rental sector and regulation of private finance, development and land.

New Deal Ruins

The right-to-buy scheme has been a key component of housing policy across the United Kingdom for thirty-five years, and while Scotland and Wales have decided to end it, in 2015 there were proposals to extend right to buy in England. But what exactly is this policy, how has it developed, and what has its impact been? Is there any evidence of wider, unintended consequences, and how might extending the policy affect future housing provisions? What alternatives are there? In this book, Alan Murie provides an authoritative account of the rise and reach of the right-to-buy policy as well as its potential future sway. Presenting up-to-date statistical data, The Right to Buy? both engages with debates about transfers to private renting and the policy's impact on public expenditure and the current housing situation, and assesses the proposals for new legislation.

The New Politics of Home

At a time when lower-income Americans face a desperate struggle to find affordable rental housing in many cities, 'After the Projects' investigates the contested spatial politics of public housing development and redevelopment.

Political Legitimacy and Housing

America is in the midst of a rental housing affordability crisis. More than a quarter of those that rent their homes spend more than half of their income for housing, even as city leaders across the United States have been busily dismantling the nation's urban public housing projects. In After the Projects, Lawrence Vale investigates the deeply-rooted spatial politics of public housing development and redevelopment at a time when lower-income Americans face a desperate struggle to find affordable rental housing in many cities. Drawing on more than 200 interviews with public housing residents, real estate developers, and community leaders, Vale analyzes the different ways in which four major American

cities implemented the federal government's HOPE VI program for public housing transformation, while also providing a national picture of this program. Some cities attempted to minimize the presence of the poorest residents in their new mixed-income communities, but other cities tried to serve as many low-income households as possible. Through examining the social, political, and economic forces that underlie housing displacement, Vale develops the novel concept of governance constellations. He shows how the stars align differently in each city, depending on community pressures that have evolved in response to each city's past struggles with urban renewal. This allows disparate key players to gain prominence when implementing HOPE VI redevelopment. A much-needed comparative approach to the existing research on public housing, After the Projects shines a light on the broad variety of attitudes towards public housing redevelopment in American cities and identifies ways to achieve more equitable processes and outcomes for low-income Americans.

Home

Homes fit for Heroes looks at the pledge made 100 years ago by the Lloyd George government to build half a million 'homes fit for heroes' – the pledge which made council housing a major part of the housing system in the UK. Originally published in 1981, the book is the only full-scale study of the provision and design of state housing in the period following the 1918 Armistice and remains the standard work on the subject. It looks at the municipal garden suburbs of the 1920s, which were completely different from traditional working-class housing, inside and out. Instead of being packed onto the ground in long terraces, the houses were set in spacious gardens surrounded by trees and open spaces and often they contained luxuries, like upstairs bathrooms, unheard-of in the working-class houses of the past. The book shows that, in the turbulent period following the First World War, the British government launched the housing campaign as a way of persuading the troops and the people that their aspirations would be met under the existing system, without any need for revolution. The design of the houses, based on the famous Tudor Walters Report of 1918, was a central element in this strategy: the large and comfortable houses provided by the state were intended as visible evidence of the arrival of a 'new era for the working classes of this country'.

The Right to Buy?

Socio-political views on housing have been brought to the fore in recent years by global economic crises, a notable rise of international migration and intensified trans-regional movement phenomena. Adopting this viewpoint, From Conflict to Inclusion in Housing maps the current terrain of political thinking, ethical conversations and community activism that complements the current discourse on new opportunities to access housing. Its carefully selected case studies cover many geographical contexts, including the UK, the US, Brazil, Australia, Asia and Europe. Importantly, the volume presents the views of stakeholders that are typically left unaccounted for in the process of housing development, and presents them with an interdisciplinary audience of sociologists, planners and architects in mind. Each chapter offers new interpretations of real-world problems, local community initiatives and successful housing projects, and together construct a critique on recent governmental and planning policies globally. Through these studies, the reader will encounter a narrative that encompasses issues of equality for housing, the biopolitics of dwelling and its associated activism, planning initiatives for social sustainability, and the cohabitation of the urban terrain.

After the Projects

Despite the fact that policy is increasingly led by the mass media, social policy research has so far focused on variables and quantitative measurement rather than cultural meanings and moral welfare debates. Taking a critical examination of social policy on public housing by way of illustration, this book demonstrates how critical discourse theory can be used in applied research. It shows how the theory and method of critical discourse analysis can be worked together in an intricate and accessible way.

Homes Fit For Heroes

Reconstructing Public Housing unearths Liverpool's hidden history of radical alternatives to municipal housing development and builds a vision of how we might reconstruct public housing on more democratic and cooperative foundations. Social Policy and Discourse Analysis

Baranski details the ways San Francisco residents turned to the public housing program to build class-based political movements in a multi-racial city and introduces us to the individuals--community activists, politicians, reformers, and city employees--who were continually forced to seek new strategies to achieve their aims as the winds of federal legislation shifted. Ultimately, Housing the City by the Bay advances the idea that public housing remains a vital part of the social and political landscape, intimately connected to the struggle for economic rights in urban America.

Housing Policy in the UK

When it comes to large-scale public housing in the United States, the consensus for the past decades has been to let the wrecking balls fly. The demolition of infamous projects, such as Pruitt-Igoe in St. Louis and the towers of Cabrini-Green in Chicago, represents to most Americans the fate of all public housing. Yet one notable exception to this national tragedy remains. The New York City Housing Authority, America's largest public housing manager, still maintains over 400,000 tenants in its vast and well-run high-rise projects. While by no means utopian, New York City's public housing remains an acceptable and affordable option. The story of New York's success where so many other housing authorities faltered has been ignored for too long. Public Housing That Worked shows how New York's administrators, beginning in the 1930s, developed a rigorous system of public housing management that weathered a variety of social and political challenges. A key element in the long-term viability of New York's public housing has been the constant search for better methods in fields such as tenant selection, policing, renovation, community affairs, and landscape design. Nicholas Dagen Bloom presents the achievements that contradict the common wisdom that public housing projects are inherently unmanageable. By focusing on what worked, rather than on the conventional history of

failure and blame, Bloom provides useful models for addressing the current crisis in affordable urban housing. Public Housing That Worked is essential reading for practitioners and scholars in the areas of public policy, urban history, planning, criminal justice, affordable housing management, social work, and urban affairs.

The Housing Debate

This groundbreaking book shows how major shifts in federal policy are spurring local public housing authorities to demolish their high-rise, low-income developments, and replace them with affordable low-rise, mixed income communities. It focuses on Chicago, and that city's affordable housing crisis, but it provides analytical frameworks that can be applied to developments in every American city. "Where Are Poor People to Live?" provides valuable new empirical information on public housing, framed by a critical perspective that shows how shifts in national policy have devolved the U.S. welfare state to local government, while promoting market-based action as the preferred mode of public policy execution. The editors and chapter authors share a concern that proponents of public housing restructuring give little attention to the social, political, and economic risks involved in the current campaign to remake public housing. At the same time, the book examines the public housing redevelopment process in Chicago, with an eye to identifying opportunities for redeveloping projects and building new communities across America that will be truly hospitable to those most in need of assisted housing. While the focus is on affordable housing, the issues addressed here cut across the broad policy areas of housing and community development, and will impact the entire field of urban politics and planning.

Reconstructing Public Housing

Lawrence Vale explores the rise, fall, and redevelopment of three public housing projects in Boston. Vale looks at these projects from the perspectives of their low-income residents and assesses the contributions of the design professionals who helped to transform these once devastated places during the 1980s and 1990s.

Making A Better World

Now considered a dysfunctional mess, Chicago's public housing projects once had long waiting lists of would-be residents hoping to leave the slums behind. So what went wrong? To answer this complicated question, D. Bradford Hunt traces public housing's history in Chicago from its New Deal roots through current mayor Richard M. Daley's Plan for Transformation. In the process, he chronicles the Chicago Housing Authority's own transformation from the city's most progressive government agency to its largest slumlord. Challenging explanations that attribute the projects' decline primarily to racial discrimination and real estate interests, Hunt argues that well-intentioned but misguided policy decisions—ranging from design choices to maintenance contracts—also paved the road to failure. Moreover, administrators who fully understood the potential drawbacks did not try to halt such deeply flawed projects as Cabrini-Green and the Robert Taylor Homes. These massive high-rise complexes housed unprecedented numbers of children but relatively few adults, engendering disorder that pushed out the working class and, consequently, the rents needed to maintain the buildings. The resulting combination of fiscal crisis, managerial incompetence, and social unrest plunged the CHA into a quagmire from which it is still struggling to emerge. Blueprint for Disaster, then, is an urgent reminder of the havoc poorly conceived policy can wreak on our most vulnerable citizens.

Housing the City by the Bay

In recent years many nations have asked why not enough housing is being built or, when it is built, why it isn't of the highest quality or in the best, most sustainable, locations. Politics, Planning and Housing Supply in Australia, England and Hong Kong examines the politics and planning of new homes in three very different settings, but with shared political traditions: in Australia, in England and in Hong Kong. It investigates the power-relationships and politics that underpin the allocation of land for large-scale residential schemes and the processes and politics that lead to particular development outcomes. Using a comparative framework, it asks: how different systems of urban governance and planning mediate the supply of land for housing; whether and how these system differences influence the location, quantity and price of residential land and the implications for housing outcomes; what can be learned from these different systems for allocating land, building consensus between different stakeholders, and delivering a steady supply of high quality and well located homes accessible to, and appropriate for, diverse housing needs. This book frames each case study in a comprehensive

examination of national and territorial frameworks before dissecting key local cases. These local cases – urban renewal and greenfield growth centres in Australia, new towns and strategic sites in England, and major development schemes in Hong Kong – explore how broader urban planning and housing policy goals play out at the local level. While the book highlights a number of potential strategies for improving planning and housing delivery processes, the real challenge is to give voice to a broader array of interests, reconstituting the political process surrounding planning and housing development to prioritise homes in well-planned places for the many, rather than simply facilitating investment opportunities for the few.

Public Housing That Worked

This volume provides a comprehensive analysis of how politics shape housing markets and vice-versa. It demonstrates how housing impacts a variety of social and political phenomenon including populist politics, generational divides, wealth inequality, monetary policy, and the welfare state. Housing and housing markets have important implications for economic stability, public policy, domestic politics and wealth inequality in Europe and beyond. Yet despite its importance, housing has received relatively little attention in comparative politics scholarship. The contributions within this volume push the scholarship of housing into fresh, innovative directions. The chapters focus on housing's contribution to wealth inequality, how housing constrains governments' policy choices in welfare state reform and how it can strengthen governments' hands in financial regulation. Other contributions reveal the impact of housing on central bankers' motivations for implementing monetary expansion, highlight the generational divide in gaining access to home-ownership, demonstrate how housing-driven wealth inequality steers voters political preferences towards right-wing populism, and explain how housing gradually shifted from being a social right to an object of investment in Europe, even within its most egalitarian states. These contributions cover a diversity of cases in Western and Eastern Europe and theoretical paradigms that will appeal to scholars and policy makers alike. The chapters in this book were originally published as a special issue of West European Politics.

Where are Poor People to Live?: Transforming Public Housing Communities

The Federal Government and Urban Housing provides a comprehensive overview of federal housing and community development policy during the last fifty years, with special emphasis on the crucial decade of the 1970s. It relates housing policy developments to broad ideological and political changes that have taken place in the U. S. during this period. R. Allen Hays covers virtually every major program that has attempted to provide housing for disadvantaged persons, including public housing, Section 235, Section 8, and housing rehabilitation. He compares the underlying approaches to housing embodied in these programs, and examines the impact of urban renewal and Community Development Block Grants on urban housing. The successes and failures of federal housing programs are considered within a detailed historical context. The book concludes with a look at housing policy under the Ronald Reagan Administration and a discussion of the future of housing policy.
