Although these nine lectures were given to an audience that had been studying anthroposophy, or spiritual science, for many years, they were nevertheless described by Rudolf Steiner as an 'introductory course'. Given shortly after the Christmas Foundation Meeting, in which Rudolf Steiner refounded and renewed the Anthroposophical Society, these lectures reformulate the content of spiritual science from a condensed, personal, experiential point of view. What Steiner presented in his fundamental work Theosophy in a descriptive, systematic way, is complemented here with great intensity, challenging us to cultivate a living experience of the spiritual nature of ourselves and of the world. This volume is therefore an invaluable companion to the book Theosophy. Given the unique nature of these lectures, they are suitable for both the advanced student and the beginner who wishes to embark on an exploration, however tentative, of the vast range of Rudolf Steiner's work.

## The Inner Life of the Earth

Rudolf Steiner is perhaps best known for his influence and wisdom in the fields of education, agriculture, medicine, science, and art. It is often forgotten that it was as a spiritual teacher that he made these contributions. ### Color and Gesture

3 selected lectures by Rudolf Steiner This is one of those books that can change your life. Radical, thought-provoking, and indeed mind-boggling, it leads to a completely new way of looking at what it means to be human--a spiritual being in a universe that itself is not just physical, but psychic and spiritual as well. These three previously untranslated lectures are a masterly introduction to what Rudolf Steiner means by "Anthroposophy." They explain why Steiner describes this path--which means literally "the wisdom of the human being"--as one that "unites what is spiritual in the human being with what is spiritual in the universe." Steiner begins by describing what happens when we die. He shows the relationship between our physical life on Earth and the etheric, astral, and spiritual life of the cosmos. He also explains how physical lives are completely interwoven with cosmic existence, and how the "missing links" in evolution are spiritual in nature. Steiner then demonstrates what he calls the "dilettantism" and "soullessness" of mainstream psychology. He points out that, since the second half of the nineteenth century, the idea of the soul has been lost and that, consequently, understanding of our inner lives is without a sure foundation. A very different view emerges, however, from a truly spiritual perspective. In the third lecture, Steiner takes as his guide our three states of being--waking, dreaming, and sleeping. He describes in detail what happens in these three states and how each is bound up with our lives as physical, psychic, and spiritual beings. With the profound insights in this book, the world becomes a much larger, richer, and more exciting place to live.

### What is Anthroposophy?

These lectures provide an excellent introduction to some of the leading themes of anthroposophy. Steiner carefully corrects certain misunderstandings that had arisen regarding his spiritual-scientific research and demonstrates how anthroposophy has nothing whatever to do with mysticism or spiritualism; nor is it simply a revival of ancient esoteric teachings. Rather, it is a genuinely modern spiritual teaching for Western humanity that builds upon the achievements of science and develops its exact methodology further into the investigation of spiritual realities through the awakening of higher organs of perception.

### Approaches to Anthroposophy

But the question remains: What is thinking? A product of chemical processes in the brain, or a spiritual activity through which we become participants in a spiritual cosmos? This is Steiner's starting point in all his work. He aims to cast off the unnecessary limits imposed on knowledge by a science that fails to examine its most fundamental epistemological premises. The lectures here are a remarkable contribution to

this lifelong project --a compelling, eloquent, insightful study and affirmation of our very humanness. Speaking to a youthful academic audience, Steiner does not confine himself to the arbitrary delineations of codified academic disciplines; on the contrary, he breaks down barriers, builds bridges, envisions a future academy in which the paths of knowledge are broadened through a genuine science of initiation to encompass our role as members and, ultimately, co-creators of the physical, soul, and spiritual universe. "Those who seek to prove something show, through the very fact that they seek to prove it, that for them what must be proved is not readily perceptible. We actually seek to prove something whenever we have no direct perception of it.... When in older, instinctive cognition people had a perception of what they called the divine being, they did not need proofs. Historically, the proofs for the existence of God began only when the perception was lost. ### Education and Modern Spiritual Life

This collection of lectures contains Steiner's strongest statements on the issues of human relationships within a spiritual community. Occasioned by a scandal involving people influenced by psychoanalysis, these lectures are Steiner's comprehensive assessment of Freud's work and psychoanalysis as a whole. Steiner shows, our physical life, including human sexuality, has spiritual roots; and that looking to sexuality for the explanation of human behavior is therefore looking in the wrong direction. He also makes clear that becoming part of a spiritual community, such as the Anthroposophical Society, entails special responsibilities and a new way of being.

### Community Life, Inner Development, Sexuality, and the Spiritual Teacher

Four of Rudolf Steiner's best-loved lectures are collected in this book. They are some of the most accessible presentations of the anthroposophic approach to life available in English. Included are: *Practical Training in Thought* *Overcoming Nervousness* *Facing Karma* *The Four Temperaments* The first lecture concerns the fundamental human activity of thinking. Everything we do, we do through thinking. The first task, then, is to realize the reality of thinking. To help us do this, Steiner gives exercises that will allow us to experience the cognitive, even clairvoyant, power of thinking. In "Overcoming Nervousness," Steiner shows us how exercises in thinking also give us the calm centered sense needed to lead purposeful, healthy lives. "Facing Karma" takes us to the heart of life, where we experience suffering and happiness. The law of karma that determines life's experiences and encounters also helps us develop the self-knowledge required for self-transformation. Finally, "The Four Temperaments" show us how the union of hereditary factors and our own inner spiritual nature shape our psychology. The guide here is the ancient classifications of sanguine, choleric, phlegmatic, and melancholic. Renewed understanding of these allows us to develop a truly modern spiritual psychology, which is the basis of all real inner development. With its many practical exercises, mantras, and meditations, this book is a fundamental introduction for anyone beginning or needing encouragement along the path of inner development.

## Autobiography

How are we connected to the world around us? This question, says Rudolf Steiner, is one that lives subliminally, drawing us into the depths of the psyche. There, our candle of consciousness tends to flicker and go out. But spiritual schooling can relight it, so that we learn to perceive realms of our being beyond the restricted self. Whilst Steiner was undertaking major lecture tours of Germany and England, he took time to address his followers at the world centre of anthroposophy in Dornach, Switzerland. He speaks here on three major topics: 'The Life of the Human Soul', 'Spiritual Striving in Relation to Earth's Evolution' and 'The Contrast Between East and West'. The common theme, however, is our mutual responsibility for what the human being and the world will eventually become – which, according to Steiner, is far from a foregone conclusion. Even the way we think can change and affect the future: the degree, for example, to which we concentrate our picturing in meditation, infusing head thinking with warmth of heart. Rudolf Steiner reveals a hugely complex picture of interrelationships between humanity and the cosmos. Our head, heart, lungs and limbs all reveal subtly different qualities of connection with the invisible realities that continue to sustain us. Our eyes, for instance, only gradually evolved into organs of sight and were once vital organs, as our lungs are now. The lungs, in turn, will similarly evolve to provide us with another form of perception. As is usually the case, Steiner addresses a wide variety of topics in addition to those above. Included in this volume are thoughts on the significance of the cinema; the nature of the halo; technology as the 'true foundation' of the modern worldview; asceticism in the Middle Ages; the world of machines and the world of rite and worship; yoga and modern meditation exercises; pain as an awakener of knowledge; the emergence of the belief in ghosts; and the connection between stomach acid and soul qualities.

## Life of the Human Soul

Use of the word soul to denote the inner world of human experience has not been fashionable in recent psychology. In this ground-breaking study, however, the author stresses that our inner life is always active as a whole entity, which calls for recognition of the human soul as a being. Drawing on ideas of Goethe, Brentano, Husserl, Scheler, and Rudolf Steiner, Zeylmans van Emmichoven uses the soul's own self-perception as his method of clarifying the mysteries of the inner life. What does he find? "The soul as an inner world participates in two worlds: an external world and...a still deeper, interior world." The soul is revealed as a mediator between the outer physical world (including the body) and the inner core of the human being, the "I." Through its intentional relationship to these two worlds, an ever-shifting stream of dynamic polarities continually courses through the soul: love-hate, joy-sorrow, pleasure-displeasure, desire-satisfaction, laughing-weeping, life-consciousness. In a compact and lively style, other soul processes are similarly examined, including doubt, volition, mental images, perceiving, judgment and decision, spatial-temporal experience, and sexual identity. The language of dreams is discussed and ordered into four types. The expressive capacity of the soul in speech, posture, temperament, and character is treated with subtlety. The author also proposes another dimension to psychology in the notion of the soul's drive for development, which unfolds through the Goethean laws of polarity, enhancement, and metamorphosis. He paints a profound picture of the higher goal of human life: the soul's gradual liberation from physical bonds to become an organ for the Self, always balanced by the soul's inclination to become an organ for the body. Along this unfinished journey, toward a full human existence, the author depicts the roles of love, wisdom, and inner death

and resurrection. As the author points out, there is an area where psychology and philosophy of life overlap and cannot be entirely separated.

### The Anthroposophical Understanding of the Soul

This is the classic account of the modern Western esoteric path of initiation made public by Steiner in 1904. He begins with the premise that "the capacities by which we can gain insights into the higher worlds lie dormant within each one of us." Steiner carefully and precisely leads the reader from the cultivation of the fundamental soul attitudes of reverence and inner tranquility to the development of inner life through the stages of preparation, illumination, and initiation. Steiner provides practical exercises of inner and outer observation and moral development. By patiently and persistently following his guidelines, new "organs" of soul and spirit begin to form, which reveal the contours of the higher worlds thus far concealed from us. Steiner in this important work becomes a teacher, a counselor, and a friend whose advice is practical, clear, and effective. The challenges we face in life require increasingly deeper levels of understanding, and Steiner's text helps readers to cultivate the capacities for such insights and places them at the service of humanity. ### How to Know Higher Worlds

7 lectures in various cities, December 3, 1906 - March 16, 1923 (CW 283) "A tone is at the foundation of everything in the physical world." This is one of many astonishing statements made by Rudolf Steiner in this collection of seven lectures on the inner realities of music. These lectures are an unusual treasure, since they are the only two groups of lectures that Steiner gave primarily on music, other than the lecture cycle for the tone eurythmy course, *Eurythmy as Visible Music*. In the first group of three lectures, given in 1906, Steiner explains why music affects the human soul so powerfully. Music has always held a special position among the arts because it is the only art form whose archetype, or source, lies not in the physical world, as with architecture, sculpture, and painting, but purely in the spiritual world-the soul's true home. Music thus directly expresses through tones the innermost essence of the cosmos, and our sense of wellbeing when we hear music comes from a recognition of our soul's experience in the spiritual world. In the remaining lectures, given in 1922 and 1923, Steiner discusses our experience of musical intervals and shows how it has undergone profound changes during the course of evolution. The religious effects of music in ancient times and the union of music with speech are considered, as well as the origin of musical instruments out of imaginations that accompanied singing. New insights are offered on the nature of the major and minor modes and on future directions of musical development. ### The Inner Nature of Music and the Experience of Tone

At the foundation of Western esoteric studies is an understanding of the evolution of consciousness. Anthroposophically based esoteric training focuses on strengthening the human soul. Ancient and modern practices are reenlivened to meet humanity's evolving needs and to fulfill our present task of cultivating freedom and love to its highest degree. Individual efforts toward developing the higher self is essential for genuine progress on the inner work path. The clear insights and exercises outlined in this book reveal the meaning and necessity of this essential effort in the present age of the consciousness soul, contributing to simultaneously enlivening both our inner and outer work. The path of developing the self and our work in the world are not separated but united through our practices and their results.

### Developing the Self

12 lectures, Berlin, Oct. 23, 1909-Dec. 16, 1911 (CW 115) This series of lectures provides the basis for an entirely new psychology. The first four lectures give a precise, dynamic understanding of the human soul in relation to the activity of the senses and to the subtle processes that make up the human being on Earth. The next four lectures focus on what we can know of the human soul based on direct observation alone. No theorizing takes place. To show what we can know of soul life through the immediacy of engaged observation of oneself and others, Rudolf Steiner refrains from using his own higher capacities of clairvoyance to form a picture of our soul life. The concluding lectures portray the relationship of soul life to spirit life, showing us how to awaken individual spirit life and how to distinguish between illusory and genuine spiritual experiences. Presented more than a century ago, we might be tempted to think that, insofar as psychology is concerned, the content of these lectures are outdated. It is also tempting to think that, because Steiner is not usually associated with the founders of modern psychology, his efforts must be considered, at best, an interesting aside. On the contrary, these lectures are actually a wellspring for the true stream of psychology, as the term itself means "soul study." A Psychology of Body, Soul, and Spirit should be read by anyone interested in psychology as well as by those interested in inner development. Whether we are involved in education, medicine, art, drama, economics, or business, the perspectives contained in this book have the potential to restore the frequently missing element of soul in psychology today. ### The Life and Work of Rudolf Steiner

As human beings, what is our true relationship to the animals on earth? What is our responsibility to our fellow creatures? Douglas Sloan explores these and other questions in this important book on

Do the animals have capacities for cognitive intelligence, emotional empathy, language, and memory? Is there a crucial difference between the human and the animal, a basic difference in kind, or only a difference in degree? Do animals have rights? Are we justified in using the animals as we wish—eating them, hunting them, experimenting on them? Rudolf Steiner presents a vision of the ultimate redemption of the animals from their suffering. What is the nature of this redemption? What is our responsibility in making it happen? In exploring these and related questions with the help of Rudolf Steiner's work and that of others on the issue, we can begin to see the importance in our time of our relating to the animals in a completely new way—a relationship that understands and respects the animals' inner spiritual being, and one that requires a deep grasp of our own spiritual being in relation to theirs. In this book, Douglas Sloan seeks to help us toward this new relationship with the animals, both in concept and in everyday action.

### The Redemption of the Animals

The focus of this book is the spiritual work in the "school"—the community—of Michael. What does this mean? At the end of the eighteenth century, the Archangel Michael revealed the new mystery that has manifested on Earth as spiritual science, or anthroposophy. Its essence involves the renewal of our knowledge of the mysteries of karma and human destiny. Those who are drawn to this school have a special relationship to the human faculty of thinking—their inner feeling for truth has the strength of iron. This feeling for truth helps them to become companions of Michael at the threshold of the spiritual world. These talks deal with the spiritual path of anthroposophy in its Christian Rosicrucian aspect. Tomberg speaks openly and honestly about meditation, the various stages of consciousness (imagination, inspiration, and intuition), the "guardian of the threshold," and the esoteric trials one encounters along the way. He concludes by describing the life of Rudolf Steiner as the life of a Christian initiate.

### The Inner Work Path

'When we know how to enter deeply into the realm of the soul, we reach understanding of the harmony that exists between successive lives on earth and the whole of the physical world outside us.' - Rudolf Steiner. In these eight lectures, given during the Great War as thousands of young men were being killed in battle, Rudolf Steiner - the great initiate of the twentieth century - describes the dramatic reality of the spiritual worlds encountered by human beings after death. He speaks of the joys and sufferings experienced in those worlds by people of different character; the vision of the 'ideal human being' that souls experience; the cosmic 'midnight hour'; the processes leading to rebirth in the world of the senses; the deeper causes behind such phenomena as materialism and criminality; and why, in the flesh, we lose our instinctive perception of the spiritual worlds. Steiner describes how knowledge of the spiritual realms, as well as the life beyond death and before birth, can be built on the foundations of modern science. Indeed, he speaks of mankind's involvement in science and its many achievements as necessary steps on the path towards a modern spirituality and true understanding of the soul, and

describes in detail some of the methods by which direct perception of the worlds of soul and spirit can be developed.

### Inner Development

This written attempt to create a spiritual anthropology was found among Rudolf Steiner's unpublished works after his death. Although fragmentary, this key work on "Anthroposophy" is of enormous interest and importance. It is work whose time has finally arrived. Here are the first steps toward the development of a true psychology of spirit, using a phenomenological approach to the human senses, the life processes, the I-experience, the human form, and the human relationship to higher spiritual worlds. Steiner struggled to express the concepts related in this book, since many of the terms used in neurology, psychology, and cognitive studies did not yet exist in 1910. Since then there has been much progress, and this translation benefits from more than eighty years of development in the study of the human senses, cognition, and, neurology. Steiner's "Anthroposophy" lies halfway between anthropology and theosophy as a means of studying the human being. On the one hand, anthropology studies the human being through the physical senses using empirical scientific method; theosophy, on the other hand, recognizes the spiritual nature of the human being based on inner experience and attempts to understand human nature within the realm of spirit. Anthroposophy takes the middle way, studying human beings as they present themselves to physical observation while, at the same time, attempting to derive indications of the spiritual foundations of phenomena through a process of "phenomenological intensification." The results of this intensification are extremely important and constitute the first steps toward a truly cognitive psychology. Included are an introduction by neurologist Dr. James Dyson, an anthroposophic doctor; a foreword by Robert Sardello, co-founder and co-director of The School of Spiritual Psychology; and a translator's preface by Detlef Hardorp. While not an easy text, Anthroposophy (A Fragment) is essential for understanding Steiner's view of the human body--especially its formation and function in relation to spirit. ### Life Between Death and Rebirth

## Anthropology and the Public Interest

**Anthropology and the Public Interest:** Field work and Theory provides an understanding of how culture affects human lives, and uses this understanding in formulating and implementing domestic social policy. This book defines basic research as contributing to theory, knowledge, and method that contributes to the advancement of social science. Organized into four parts encompassing 19 chapters, this book begins with an overview of the greatest potential payoff for the advancement of social science and for enlightened social programming. This text then presents an insightful discussion of why cultural differences among people have gone so largely unrecognized. Other chapters consider the cultural or language processes of contemporary U.S. populations. This book discusses as well the changing environment that gave rise to the tremendous growth in academic anthropology. The final chapter deals with social indicators research and discusses the potential role of anthropology in such work. This book is a valuable resource for anthropologists.

## Common Ground

**Inequity of control over food systems** is a particularly insidious form of injustice. Collectively, the contributors to this volume posit that this inequity is rooted in power asymmetries in the U.S. food system and codified through U.S. food policies. This process puts the public at risk in the U.S. and, via trade and foreign aid policies, in the Global South. Inequities are manifest in the allocation of food and food-producing resources in favor of the wealthy, exploitation of the natural environment for short-term gain of private interests over long-term public ones, the framing of public discussion on food and food deprivation, and finally, the deflection of moral challenges posed by human rights to food. The contributors draw on long-term anthropological field research to examine these tensions and their on-the-ground outcomes in diverse cultural and national contexts. The authors' insightful analyses span a wide variety of topics including dietary change, food insecurity, livestock production, and organic farming in the light of U.S. trade, food, labor, and agricultural policies and food assistance programs. The collection highlights the obstacles to, and the dilemmas and inconsistencies in, shaping policy in the public interest. ## U.S. Food Policy

**How do anthropologists address the public? What makes an anthropology book popular?** Anthropology written for a popular audience is the most neglected branch of the discipline. In *Popularizing Anthropology*, anthropologists examine the way they write for a non-academic audience: what kind of books they produce; how they are written; what the pitfalls and advantages are; and what becomes popular how, when, and why. In the 1980s postmodernist anthropologists began to explore the literary and reflective aspects of their work. This book advances that trend by looking at a key but previously marginalized genre of anthropology. The contributors, who are well known anthropologists, explore such themes as: why so many popular anthropologists are women; how the Japanese have reacted to Ruth Benedict; why Margaret Mead became so successful; how the French media promote Lévi-Strauss and Louis Dumont; why Bruce Chatwin tells us more about Aborigines than many anthropologists of Australia; and how personal accounts of fieldwork have evolved since the 1950s. *Popularizing Anthropology* unearths a submerged tradition within anthropology and reveals that, from its beginning, anthropologists have looked beyond the boundaries of the academy for their audience.
