The Ascent of the Detective

This open access book surveys drinking in Britain between the Licensing Act of 1869 and the wartime regulations imposed on alcohol production and consumption after 1914. This was a period marked by the expansion of the drink industry and by increasingly restrictive licensing laws. Politics and commerce co-existed with moral and medical concerns about drunkenness and combined, these factors pushed alcohol consumers into the public spotlight. Through an analysis of public and private records, medical texts and sociological studies, the book investigates the reasons why Victorians and Edwardians consumed alcohol in the ways that they did and explores the ideas about alcohol that circulated in the period. This book shows that they had many reasons for purchasing and consuming alcoholic substances and these were driven by broader social, cultural, medical and commercial factors. Although drunkenness may have been the most visible consequence of alcohol consumption, it was not the only type of drinking behaviour. Alcohol played an important social role in the everyday lives of Victorians and Edwardians where its consumption held many different meanings.

Rule Britannia

Sir Francis Bertie (from 1915 Lord Bertie of Thame) was a senior British diplomat of the late Victorian and Edwardian eras. He is perhaps best known for the thirteen years between 1905 and 1918 during which time he was Britain's ambassador in Paris, and it is with this period of his life that Dr Hamilton is mainly concerned. The book thus examines his contribution to the evolution and maintenance of the entente cordiale, the nature of his 'anti-Germanism', his influence upon Sir Edward Grey and other British statesmen, and the eclipse of professional diplomacy during the first world war. Above all it is a study of a man whom another British diplomat was later to describe as 'the very last of the great ambassadors'.

Victorian and Edwardian Oxfordshire

Motherhood, Respectability and Baby-Farming in Victorian and Edwardian London explores a largely obscured marketplace of motherhood that provided ways for women to manage the stigma of illegitimacy and their respectable identities within Victorian and Edwardian society. It focuses on the extent of women's 'dirty work', when maternal problem management was fundamental to the general maintenance of respectability and, by extension, to Empire and Civilisation. Despite its intrigue, history has struggled to understand and represent an uncomfortable but significant artefact of Western modernising society: 'baby-farming'. During a period when ideologies of respectability and civilisation arguably mattered most, the 'right' kind of parenthood – especially motherhood – became paramount. As the 'wrong' offspring could jeopardise a woman's chances of being respectable, a wholesale, informal, and somewhat clandestine marketplace emerged that catered to various maternal difficulties. Within this marketplace, a pregnancy or newborn child who may have compromised a woman's respectability could be 'disposed' of through different means, for a fee. This book provides a revised, far more complex, and nuanced narrative history which reveals all that was associated with baby-farming – including all possible outcomes – to be entirely natural, rational, and even necessary products of their time; an understandable outcome of the period's 'civilising offensive'. Motherhood, Respectability and Baby-Farming in Victorian and Edwardian London will be of great interest to students and scholars of criminology, sociology, history, and gender studies.

The Illustrated London News Social History of Edwardian Britain

This, the third volume to appear in the New Oxford History of England, covers the period from the repeal of the Corn Laws to the dramatic failure of Gladstone's first Home Rule Bill. In his magisterial study of the mid-Victorian generation, Theodore Hoppen identifies three defining themes. This, he argues, was generated not by a series of influences operating independently from each other, but by a variety of intermeshed political, economic, scientific, literary and artistic developments. This original and authoritative book will define these pivotal forty years in British history for the next generation.

Motherhood, Respectability and Baby-Farming in Victorian and Edwardian London

This book traces the nature of change within the country community of England and Wales between 1870 and 1918--a period that was, in many respects, a watershed in British history. Victorian & Edwardian North Riding

When it appeared in 1981, this book was the first major study of the games ethos which dominated the lives of many Victorian and Edwardian public schoolboys. Written with Professor Mangan's customary panache, it has become a classic, the seminal work on the social and cultural history of modern sport.

The Victorian And Edwardian Schoolchild

In the heyday of Empire just before the First World War, Lord Cromer was second only to Lord Curzon in fame and public esteem. In the days when Cairo and Calcutta represented the twin poles of British power in Asia and Africa, Cromer's commanding presence seemed to radiate the essential spiritof imperial rule. In this first modern biography Roger Owen charts the life of the man revered by the British and hated by today's Egyptians, the real ruler of Egypt for nearly a quarter of a century. A member of the famous City banking family of Baring Brothers, Cromer in his youth seemed to be distinguished mainly by lack of academic ability and a taste for the fashionable pursuits of his day. His first military posting, to Corfu, was welcomed by him on account of the excellent shooting to behad in the region. Roger Owen shows how, almost imperceptibly, his commitment to public service grew, due in part at least to his relationship with Ethel Errington who, after long delay, became his first wife. From the island outposts of the old British Empire, to India, the jewel in its crown, and finally to the new Empire in Africa, Cromer represented the might of Britain's Empire. Few imperial administrators had either his range of experience or his long practice of ruling different non-Europeanpeoples, at a time when the whole notion of Empire itself entered more and more into the metropolitan political debate. Roger Owen makes extensive use of Cromer's official correspondence, family papers, memoirs, and the personal letters of his friends and colleagues to explore all aspects of Cromer's life in imperial government. He examines his innovative role in international finance and his energetic re-engagement with Britain's troubled political life following his formal retirement in 1907. Finally, he assesses the sometimes bitter legacy of imperial rule left by Cromer.

Reimagining Dinosaurs in Late Victorian and Edwardian Literature

Gerald Howard-Smith's life is intriguing both in its own right and as a vehicle for exploring the world in which he lived. Tall, boisterous and sometimes rather irascible, he was one of the so-called 'Lost Generation' whose lives were cut short by the First World War. Brought up in London, and educated at Eton and Cambridge, he excelled both at cricket and athletics. After qualifying as a solicitor he moved to Wolverhampton and threw himself into the local sporting scene, making a considerable name for himself in the years before the First World War. Volunteering for military service in 1914, he was decorated for bravery before being killed in action two years later. Reporting his death, the War History of the South Staffordshire Regiment claimed that, 'In his men's eyes he lived as a loose-limbed hero, and in him they lost a very humorous and a very gallant gentleman.' As well as telling the fascinating story of Gerald Howard-Smith for the first time, this important new biography explores such complex and important issues as childhood and adolescence, class relations, sporting achievement, manliness and masculinity, metropolitan-provincial relationships, and forms of commemoration. It will therefore be of interest to educationalists, sports historians, local and regional historians, and those interested in class, gender and civilian-military relations – indeed all those seeking to understand the economic, social, and cultural life of late nineteenth and early twentieth-century Britain.

The Lancashire Cotton Industry

Lancashire was once the Cotton Capital of the world. Raw cotton came in to Liverpool docks and was sold on the Exchange. In the beginning, it was then transported to cottages all over the county where whole families, including the children, would clean, card, spin and weave it. The finished cloth was then sold on the Manchester Exchange. With the coming of the Industrial Revolution new machines saw the work transferred from home to factory. It was said that Lancashire could produce enough cotton before breakfast to supply the UK market, with the remainder of the day's supply going overseas. Read the first hand accounts from local people, and look at the remarkable collection of contemporary photographs.

Memories of the Lancashire Cotton Mills

In Lancashire the cotton mill dominates many a skyline, even today. Stott & Sons is a unique and fascinating study of one of the most crucial architects? practices working in this field. Over 150 illustrations and gazetteer. spinning town in Britain and architects from Oldham came to dominate the business of designing cotton spinning mils in Lancashire. This book traces the history of Stott & Sons, who were one of the oldest and most prominent firms in the business. Stott, senior, set up an office in Oldham and he was later joined in partnership by two of his sons. They were also involved in the promotion of cotton spinning companies and, as a general architectural practice, designed other buildings including houses, schools and a watch factory. The records of the firm have not survived, but the author has used a variety of sources ranging from Building Regulation records to newspapers and trade journals. Most importantly he has looked at the mills themselves in the belief that industrial archaeology has a major contribution to make in understanding the history of the Lancashire cotton industry.

Stott & Sons

Located on the eastern edge of the Lancashire plain on the banks of the River Chor, at the center of a rich agricultural area, Chorley was a market town from medieval times. This beautifully presented book depicts the growth and prosperity which arose with the Industrial Revolution, through juxtaposing images of streets, buildings, and people. The photographs feature aspects of industry such as cotton weaving and spinning; coal mining and quarrying; and canal and railway links. Images showing the physical development are accompanied by changes in costume and custom, transport and trading, sport and entertainment. Informative captions will help the reader understand how all this contributed to the rich history of Chorley.

Sabden Past and Present

"A Victorian Society" is a book about early photography and photographers, told against the backdrop of life in what was to become the most productive cotton spinning town in the world. In 1867, when photography was still in its infancy, a group of photographers from Oldham and District met at the Hare and Hounds Inn, Yorkshire Street, and founded the Oldham Photographic Society and some of these men would provide the early photographic studios in the town. The photographic portrait had been accessible only to the wealthy but now it was beginning to be affordable by all but the poorest in society. One evening each week, the early photographers of Oldham met to share knowledge and to collect photographs in their album, which has mostly lain unseen in the society's archives for over 100 years. "A Victorian Society" has more than 300 black and white photographs and illustrations, many of which are published here for the first time. The book first traces the early days of photography through the lives of the pioneers, in France and Britain, whose work led to the creation of the permanent photographic image, paving the way for all professional and amateur photography. After the Lancashire cotton famine, the late 1860s marked the beginning of the most exciting period of Oldham's history. The author examines the rise of the town to become one of the most important cotton spinning and textile engineering towns in the world and follows its progress through phenomenal growth to eventual decline. The Victorian age was the "Age of Invention" and the Oldham Photographic Society reflects that through its early members, many of whom rose to prominence in the world of photography, commerce and manufacturing, some of their businesses achieving national and international importance. Using genealogy sources and historic publications, the author researched the lives of many of the society's Victorian members and brings them together in a social group not studied before. Their stories give a real insight into their origins, successes, rise to fortune, failures and personal tragedies. The book concludes with a guide on how to date old photographs.

The Lancashire Cotton Industry, a Study in Economic Development

Chadderton Mill, built 1884-85, was one of the many cotton spinning mills in Oldham, Lancashire. When it closed in 2000 it was one of the last mills in Oldham to be used by the textile industry, latterly for winding and doubling. Still standing, it is listed grade 2 because it is considered to be a good example of a spinning mill of its period. This well illustrated book places the mill in the context of the Lancashire cotton industry, looking at the origins and financing of the mill together with subsequent changes in ownership. The original construction, layout of machinery and workforce of the mill are described as are later extensions including change of use in the 1930s. Many of the illustrations were taken by the author before the mill closed in 2000.

Cotton

Preston was no ordinary town during the nineteenth century. While king cotton reigned supreme throughout Lancashire, the underlying ills associated with this industry were very often highlighted particularly starkly there. This book presents an indictment of the industrial system that caused such suffering to Preston's cotton 'martyrs'.

It includes an enquiry into the causes of the Lancashire cotton famine, which contradicts the historical consensus on the subject. Examining the impact of the civil war on Liverpool and its raw cotton market, this thought-provoking book demonstrates how reckless speculation infested and distorted the market, and lays bare the shadowy world of the Liverpool cotton brokers, who profited hugely from the war while the rest of Lancashire starved.

The Silent Mills

The Mill Girls

This is the first of three volumes of photographs with brief notes. The volumes have been divided roughly into geographic order, this first book starting at Woodbridge Mill in the north, and working down as far as the shops and the school, all of which fell within Littleton Panell during the 19th Century. Also included in this volume are many photographs of village celebrations; fetes, carnivals, and outings, and school photographs dating from the late 19th Century, some from Little Cheverell and a few from Market Lavington.

This book is part of the Images of England series, which uses old photographs and archived images to show the history of various local areas in England, through their streets, shops, pubs, and people.

In & Around Wigan Through Time

Once a major cotton spinning town, there were at one time over twenty mills in Chorley. The first steam-powered cotton mills and the Lancaster Canal to the east of the town were built in the late 1790s and the railway was connected to Chorley from Bolton in 1841. The Royal Ordnance Factory

was established in 1939 and produced ammunition until winding down in 2002. Since then the biggest housing development in Lancashire has been taking place on the site: the building of a complete new village called Buckshaw. Despite the loss of some heritage, Chorley still has three mills in use locally, as well as Astley Hall and Park, the new Yarrow Valley Country Park and Healey Nab. In this book a wonderful collection of old photographs are compared and contrasted with modern equivalents, unveiling amazing changes and unexpected similarities.
