#### New Asian Regionalism

This collection of selected studies by well-known experts in major Asian countries surveys, discusses and analyzes emerging problems and challenges facing them. ### Responses to Regionalism in East Asia

In the decade following the Asian financial crisis, the East Asian political economy has experienced a radical transformation. This book thus investigates the responses of Japanese automotive makers to the processes of regionalism and regionalization by locating firm-level analysis in a broader political economy context.

#### The United States and China

With its long history of internal divisiveness and its intersecting cultural and linguistic cleavages, East Asia is undoubtedly a complex area. However, the idea of East Asia as a regional entity is one that is relatively recent – a concept that gained momentum after the financial crisis that rocked the region in the 1990s. In recent years, East Asia has become considerably more interdependent, connected and cohesive. This increased cohesiveness has been driven by a dense network of trade and investments, technology sharing and communication, among many other variables and has been reflected in the increasing institutionalisation of regional mechanisms like the ASEAN. Regionalism is not, however, entirely about economic interdependence. In today's day and age, it means not only overarching social networks and a regional identity, but also strategic thinking that recognises common security interests. This book takes into account the regional discourses of two of East Asia's biggest players – the United States and China. While the former has been a power to reckon with, albeit "externally", deeply entrenched in the region since the end of the Second World War, the rise of China in the 21st century and its emergence as the largest power in East Asia has brought a new perspective to East Asian regionalism. In 2010, the United States began reasserting itself in East Asia, bringing into sharp focus the ideological differences between itself and China as each vied to shape the architecture of East Asian security. There is no doubt that heightened American interest comes at a time when China's own views of regionalism have become noticeably less cooperative. While balance of power politics is one way to look at the geopolitical tug-of-war in East Asia, there are questions that have not yet been answered. How do the two countries look at a region that is so important for them? How has that perception influenced their foreign policy within the same arena? More importantly, how do they define East Asia? This book studies American and Chinese regional discourses from the end of the Cold War to the present day in order to highlight the rationale behind the natural balance of power politics between an established power and a rising one, and its subsequent effects on security regionalism in East Asia.

Wunderlich's research offers an in-depth analysis of the interrelated drivers, spoilers and dissolvers of regional institution-building processes in Europe and East Asia, and addresses key questions including: Under what conditions does regionalism take hold? What is influencing the initial institutional design choices? What is the impact of historical experiences and well-entrenched norms and ideas? What are the roles of regional leaders? How do external factors influence regional institution-building? What turns a crisis into a critical juncture and are such junctures threats or opportunities? What accounts for variations in institutional responses to crisis events across different regional settings? This book will be a valuable resource for scholars of regionalism, region-building, regional governance and international relations of Europe and East Asia.

#### (Re)Negotiating East and Southeast Asia

Written with rare mastery and a sure sense of the essential, this concise general history of modern East Asia offers students and general readers an understanding of this dynamic region from a global perspective. It is the ideal introductory text for college survey courses in Asian and international studies. Following an introductory discussion of the regional concept, the first two chapters lay the foundations. Chapters 8 and 9 span the cold war era, from postwar U.S. hopes for a "Pax Americana" to the division of East Asia into communist and anti-communist blocs. The Sino-Soviet split and the Sino-American rapprochement of the early 1970s open the way to the "East Asian miracle" and a resurgence of East Asian regionalism, surveyed in Chapter 10. A concluding chapter considers the prospects for continued economic dynamism and the balance of nationalism and pan-Asian trends in shaping the future.

# European and East Asian Regionalism

Combining state and subnational perspectives in conjunction with an examination of the role of the business community and civil society organisations, this book highlights the policy challenges confronting regionalism and governance in East Asia, including key issues such as the rule of law, financial cooperation and a case study on disaster management.

#### **Pacific Currents**

East Asian countries - currently the most dynamic region of the global economy - have recently pursued trade liberalization through the adoption of various forms of bilateral and plurilateral Free Trade Agreements (FTAs). The book explores the key issues and possible outcomes arising from this departure from the region's traditional multilateral approach to trade liberalization. Implications of this new approach for the region as a whole, and key participating individual economies and blocs of economies, are emphasized. New East Asian Regionalism includes up-to-date analysis of the most recent developments in FTAs between countries in East Asia, as well as those involving countries from outside the region. Furthermore, the book includes invaluable projections on economic and welfare outcomes of regional trade agreements, using the very latest empirical techniques, and data. The book also considers the implications arising from closer financial integration in the region. This book will be warmly welcomed by scholars of regional science, international economics and business, as well as Asian studies. Policymakers at both the national government and international organization level will also find this book of great interest.

# Governance and Regionalism in Asia

Institutional activities have remarkably transformed East Asia, a region once known for the absence of regionalism and regime-building efforts. Yet the dynamics of this Asian institutionalization have remained an understudied area of research. This book offers one of the first scholarly attempts to clarify what constitutes institutionalization in East Asia and to systematically trace the origins, discern the features, and analyze the prospects of ongoing institutionalization processes in the world's most dynamic region. Institutionalizing East Asia comprises eight essays, grouped thematically into three sections. Part III discusses the institutionalization dynamics at the sub-regional and inter-regional levels. The essays in this book offer a useful source of reference for scholars and researchers specializing in East Asia, regional architecture, and institution-building in international relations. They will also be of interest to postgraduate and research students interested in ASEAN, the drivers and limits of international cooperation, as well as the role of regional multilateralism in the Asia-Pacific region.

# New East Asian Regionalism

In the wake of the financial crisis in East Asia in the second half of 1997/8, East Asia has taken serious consideration of the prospects for regional community building. South Korea and Japan, who had limited engagements in foreign/regional policy during the Cold War, developed different responses and approaches toward East Asian regionalism. Observing their efforts in building regional cooperation during the period between 1998 and 2007, it is notable that South Korea had been relatively active, whereas Japan had been passive in response to its neighbour's involvement in the East Asian regional framework, particularly in regard to China's role in shaping regional cooperation. Drawing on four mechanisms of diffusion (coercion, competition, lesson-drawing, emulation), this book provides not only explanations for the two countries' differential approaches toward East Asian regionalism, but also

advances a plausible account of how South Korea's EU-inspired vision of regional integration and its assimilation of European ideas about regional integration associate strongly with its active engagement in a newly emerged East Asian regionalism.

#### Institutionalizing East Asia

The book analyses modern tendencies in the development of regional economic cooperation in East Asia which is considered by regional countries as their response to growing challenges of globalization. Trying to protect their national interests by collective efforts they are promoting regional commercial, investment, and financial cooperation as measures aimed at improving the efficiency of their economies. These steps however are not regarded as a counterweight to globalization but merely directed against most negative manisfestations of the latter and in fact are realized as one of the forms of globalization at the regional level.

# How Ideas of European Integration Matter?

Regional cooperation in East Asia on various issue areas, such as emergency liquidity mechanisms in finance, the exponential growth of free trade agreements and policy coordination on the environment and public health, developed rapidly after the Asian Financial Crisis. A decade later, the global financial crisis offered a new opportunity for the nascent regional cooperation mechanisms to acquire new depth and meaning - this time, however, in a very different context due to the unfaltering rise of China. How have inter-state cooperation mechanisms, which were devised originally to deal with the problems of the past crisis, fared in the recent global economic turbulence? Can regional integration effectively insulate East Asia from the vagaries of the international market? Should East Asian nations heed the call for regionalism or globalism? This volume not only offers one of the first assessments of how the global economic crisis has affected the prospects for regional integration in East Asia, but it also addresses a number of long-standing debates of interest to East Asian specialists, economists and policymakers: Are crises catalysts for revamping developmental models? Do they provide solid foundations for regional solidarity and integration? Can they help catapult countries into the global limelight? This book was originally published as a special issue of The Pacific Review.

#### East Asia

The essays in this volume provide the Indian and Southeast Asian perspectives on some of the geo-political and security challenges facing South and Southeast Asia. These include the interests and role of major outside powers in the two regions and the relations between these powers; the trends in Asian regionalism, especially the ASEAN-led regionalism and India's place in it; the growing maritime and naval interests of the two rising Asian powers, China and India; and the impact of climate change. Also addressed are two specific issues of great potential importance for the security calculus of the two regions: the South China Sea and Myanmar.

# The Global Economic Crisis and East Asian Regionalism

As Japan's newfound economic power leads to increased political power, there is concern that Japan may be turning East Asia into a regional economic bloc to rival the U.S. and Europe. In Regionalism and Rivalry, leading economists and political scientists address this concern by looking at three central questions: Is Japan forming a trading bloc in Pacific Asia? Does Japan use foreign direct investment in Southeast Asia to achieve national goals? Does Japan possess the leadership qualities necessary for a nation assuming greater political responsibility in international affairs? The authors contend that although intraregional trade in East Asia is growing rapidly, a trade bloc is not necessarily forming. They show that the trade increase can be explained entirely by factors independent of discriminatory trading arrangements, such as the rapid growth of East Asian economies. Other chapters look in detail at cases of Japanese direct investment in Southeast Asia and find little evidence of attempts by Japan to use the power of its multinational corporations for political purposes. A third group of papers attempt to gauge Japan's leadership characteristics. They focus on Japan's "technology ideology," its contributions to international public goods, international monetary cooperation, and economic liberalization in East Asia.

#### South and Southeast Asia

# Regional Integration in East Asia and Europe

#### Contested Forces?

This dissertation set out to establish why it was that East Asian regional organizations were proliferating even under the condition of a Sino-Japanese rivalry. In particular, it examined the effects of the rise

of China on Japan's regional policy and its outcomes. To do so, the dissertation adopted an eclectic approach, testing each of the main international relations theories against the story of Sino-Japanese relations within the studied regional institutions of East Asia. It adopted such an approach because no one theory of international relations was able to explain both the cause of and actual outcomes of institution building. Throughout all the regional institutions examined, one trend emerged. Whether in trade, finance, security or development, East Asian regionalism has become 'networked.' This networked outcome is more flexible than European or American-type regionalism, allowing for any dyad to calibrate their commitments as they please without reference to a regional standard. But as long as agreement on common rules for East Asia remains unforthcoming, this networked regionalism will not lead into more formalistic, deeper cooperation. This trend toward a 'networked' or bilateral-type of regionalism was traceable back to Japan's response to China's rise. Rather than trying to build a regionally hegemonic core around which institutions for trade, finance, aid and security might be built, Japan has sought to go it alone. In the field of security, this was understandable from a realist perceptive, but only after a constructivist strategy had failed earlier. In the field of aid, Japan was better able to coordinate with China in a manner that liberalism suggests, but even here Japan was building up alternative bilateral structures. In the field of finance, Japan has competed with China in a manner realism would predict, but due to world level factors this has in fact spilled over into greater regional cooperation. Likewise in the field of trade, Japan has competed with China, giving rise to a situation in which institution building is actually harmed. In conclusion, this dissertation was able to contribute to the literature by revealing the mechanisms by which a bilateral relationship impacts on institution building and to theorize about some of the likely institutional outcomes in the various fields.

# The Asian Regional Response to Its Economic Crisis and the Global Implications
