International Transmission of Population Policy Experience

Since its early years, the United Nations has issued a series of international recommendations on population and housing censuses under the title "Principles and Recommendations for Population and Housing Censuses". These publication series, which are based on good national practices in census taking, are widely used by national statistical offices and census officials in countries throughout the world in planning and carrying out population and housing censuses, as well as other related data collection activities, particularly demographic and and socio-economic surveys. The recommendations provide guidance on the main characteristics of population and housing censuses, general material on census methodology, planning, and operations, and more detailed guidance on the content of censuses, in terms of topics for population and also housing. These series are currently revised to assist countries in preparing for the 2020 round of censuses by taking into account changes in methodology, technology, as well as the need for better data dissemination and utilization.

Population Growth and Demographic Structure

The general assumption throughout history has been that a growing population is beneficial for societies. By the mid-1960s, however, the United States and other developed countries became convinced that population control was an absolute necessity, especially in the developing world. This absorbing study explains why population control is no longer the focus of global population policy and why reproductive rights and health have become the major focus. The book highlights the role that the US and other developed countries play in affecting global population policy, looking in particular at the stance of the George W. Bush administration since taking office. It also studies the influence of the UN as an international forum and explores how civil society questioned the ethics of population control. Global Population Policy will appeal to a wide audience, including readers in the fields of women's studies, development politics and international relations.

Population Distribution and Migration

The population and housing census is part of an integrated national statistical system, which may include other censuses (for example, agriculture), surveys, registers and administrative files. It provides, at regular intervals, the benchmark for population count at national and local levels. For small geographical areas or sub-populations, it may represent the only source of information for certain social, demographic and economic characteristics. For many countries the census also provides a solid framework to develop sampling frames. This publication represents one of the pillars for data collection on the number and characteristics of the population of a country.

Advances in the biomedical sciences have raised pertinent, and often paradoxical, questions concerning the relationship between women's health and their rights. Principles and Recommendations for Population and Housing Censuses, Revision 3

At the heart of the matter lies a paradox: although the overall trend among rich countries is for fertility to decrease as female labor participation increases, gender-friendly countries resist the trend. Conversely, gender-unfriendly countries have lower fertility rates than they would have if they changed their labor markets to encourage the hiring of women—and therein lies Japan's problem. The authors argue that the combination of an inhospitable labor market for women and insufficient support for childcare pushes women toward working harder to promote their careers, to the detriment of childbearing. Controversial and enlightening, this book provides policy recommendations for solving not just Japan's fertility issue but those of other modern democracies facing a similar crisis.

It builds on previous revisions by incorporating additional results from the 2010 and 2020 rounds of national population censuses as well as information from vital registration and recent nationally

representative household sample surveys. The 2019 revision also presents population projections to the year 2100 that reflect a range of plausible outcomes at the global, regional and country levels. These Highlights summarise key population trends described by the estimates and projections presented in World Population Prospects 2019.

Causes of International Migration

The report presents findings from the 2018 revision of World Urbanization Prospects, which contains the latest estimates of the urban and rural populations or areas from 1950 to 2018 and projections to 2050, as well as estimates of population size from 1950 to 2018 and projections to 2030 for all urban agglomerations with 300,000 inhabitants or more in 2018. The world urban population is at an all-time high, and the share of urban dwellers, is projected to represent two thirds of the global population in 2050. Continued urbanization will bring new opportunities and challenges for sustainable development.
