McCurdy shows that the Quartering Act had significant ramifications, codified in the Third Amendment, for contemporary ideas of the home as a place of domestic privacy, the city as a place without troops, and a nation with a civilian-led military.

Spanish Colonial Fortifications in North America 1565–1822

Black and White Manhattan
