Simply defined: Bootstraps are persons inclined to focus on what individuals can do to improve their own circumstances. Benefits are persons inclined to focus on what society can do to improve the circumstances of groups of people. Scott Miller is a liberal, founder of Circles USA and advocate for creating smarter systems to reduce poverty while emphasizing the importance of self-responsibility. Denise Rhoades is a conservative who, for many years, volunteered in Circles supporting families as they make their way out of poverty, while also advocating for smarter public policy and programs. As Scott explains: "When Denise told me her observation-that I am fluent in progressive/liberal, but can speak conservative with an accent-I was both amused and appreciative to have someone share such a unique perspective. Similarly, Denise is a conservative who 'gets it' when it comes to reducing versus managing poverty. "The strategies to ending poverty in the United States, while somewhat complex, are not the rocket science "experts" would have us believe. We have made it far too complicated to motivate people to take necessary actions. And we have become distracted by arguments that protect our cherished ideals and beliefs about one another: Bootstraps and Benefits. At the heart of all this are real people whom most of us, including policymakers, rarely get to know. Conservatives need to recognize that large numbers of people in poverty and receiving government assistance really do want to work and have the same personal aspirations for themselves and their families as anyone else, but the ladder for moving up and out of poverty is missing the bottom rungs. Liberals need to recognize that much of the government funding spent to address poverty, however well intentioned, often goes toward managing poverty, not reducing it. If we involve the real experts-those individuals who are working hard, vet not getting ahead-"We might be surprised by their answers. We would surely learn more about the challenges of moving out of poverty than we ever knew." This book will help persuade both Bootstraps and Benefits to join the cause to begin the end of poverty.

### Congressional Record

For decades, civil rights activists fought against employment discrimination and for a greater role for African Americans in municipal decision-making. As their influence in city halls across the country increased, activists took advantage of the Great Society—and the government jobs it created on the local level—to advance their goals. A New Working Class traces efforts by Black public-sector workers and their unions to fight for racial and economic justice in Baltimore. The public sector became a critical job niche for Black workers, especially women, a largely unheralded achievement of the civil rights movement. A vocal contingent of Black public-sector workers pursued the activists' goals from their government posts and sought to increase and improve public services. They also fought for their rights as workers and won union representation. During an era often associated with deindustrialization and union decline, Black government workers and their unions were just getting started. During the 1970s and 1980s, presidents from both political parties pursued policies that imperiled these gains. Fighting funding reductions, public-sector workers and their unions defended the principle that the government has a responsibility to provide for the well-being of its residents. Federal officials justified their austerity policies, the weakening of the welfare state and strengthening of the carceral state, by criminalizing Black urban residents—including government workers and their unions. Meanwhile, workers and their unions also faced off against predominately white local officials, who responded to austerity pressures by cutting government jobs and services while simultaneously offering tax incentives to businesses and investing in low-wage, service-sector jobs. The combination of federal and local policies increased insecurity in hyper-segregated and increasingly over-policed low-income Black neighborhoods, leaving

residents, particularly women, to provide themselves or do without services that public-sector workers had fought to provide.

### Social Solutions to Poverty

Although millions of Americans live below the poverty line, economic inequality is still a frequently misunderstood issue. Myths about poverty that have been thoroughly debunked are still commonly circulated, and this type of misunderstanding leads to poor communication and tension between people of different economic classes. The goal of this volume is to reduce that misunderstanding and present readers with the facts and realities of economic inequality. In-depth sidebars, full-color photographs, and educational graphs present essential information about this complex issue. Annotated quotes are also included to provide first-person perspectives to deepen readers' critical thinking skills.

The book explores some painful truths about poverty intended to show its side effects. We dive into some realities that on the surface seem rational...until the truth is revealed. For example, a minimum-wage job in a McDonald's restaurant won't lift a person out of poverty, but a college education will. With the incarceration rate in Baltimore and throughout America among the highest in the world, the book asks some hard questions. Among them: How do we ensure that formerly incarcerated men and women become part of the solution? How can we convince corporate moguls from Nike, Under Armour, and Apple to build and assemble more products here in America--and why not in Baltimore?--as part of a job creation strategy? How do we convince corporate America that exercising their corporate responsibility to create jobs in American cities is more desperately needed now than ever? Lastly, Uprising in the City looks at other urban cities across the country, and their connections and similarities in facing the same issues that Baltimore struggles with. The book provides real answers as to how we in Baltimore can become champions of change and set a precedent for the nation to follow.
