### From Barbarians to New Men

How did the Greeks view foreign peoples? This book considers what the Greeks thought of foreigners and their religions, cultures and politics, and what these beliefs and opinions reveal about the Greeks. The Greeks were occasionally intrigued by the customs and religions of the many different peoples with whom they came into contact; more often they were disdainful or dismissive, tending to regard non-Greeks as at best inferior, and at worst as candidates for conquest and enslavement. Facing up to this less attractive aspect of the classical tradition is vital, Thomas Harrison argues, to seeing both what the ancient world was really like and the full nature of its legacy in the modern. In this book he brings together outstanding European and American scholarship to show the difference and complexity of Greek representations of foreign peoples - or barbarians, as the Greeks called them - and how these representations changed over time. The book looks first at the main sources: the Histories of Herodotus, Greek tragedy, and Athenian art. Part II examines how the Greeks distinguished themselves from barbarians through myth, language and religion. Part III considers Greek representations of two different barbarian peoples - the allegedly decadent and effeminate Persians, and the Egyptians, proverbial for their religious wisdom. In part IV three chapters trace the development of the Greek-barbarian antithesis in later history: in nineteenth-century scholarship, in Byzantine and modern Greece, and in western intellectual history. Of the twelve chapters six are published in English for the first time. The editor has provided an extensive general introduction, as well as introductions to the parts. The book contains two maps, a guide to further reading and an intellectual chronology. All passages of ancient languages are translated, and difficult terms are explained.

#### **Greeks And Barbarians**

The name Attila the Hun has become a byword for barbarism, savagery and violence. Attila was coarse, capricious, arrogant, ruthless and brilliant. An illiterate and predatory tribal chief, he had no interest in administration, but was a wily politician, who, from his base in the grasslands of Hungary, used secretaries and ambassadors to bring him intelligence on his enemies. He was a leader whose unique qualities made him supreme among tribal leaders, but whose weaknesses ensured the collapse of his empire after his death.

#### Tales of the Barbarians

This book is an ambitious synthesis of the social, economic, political and cultural interactions between Greeks and non-Greeks in the Mediterranean world during the Archaic, Classical and Hellenistic periods. Instead of traditional and static distinctions between Greeks and Others, Professor Vlassopoulos explores the diversity of interactions between Greeks and non-Greeks in four parallel but interconnected worlds: the world of networks, the world of apoikiai ('colonies'), the Panhellenic world and the world of empires. These diverse interactions set into motion processes of globalisation; but the emergence of a shared material and cultural koine across the Mediterranean was accompanied by the diverse ways in which Greek and non-Greek cultures adopted and adapted elements of this global koine. The book explores the paradoxical role of Greek culture in the processes of ancient globalisation, as well as the peculiar way in which Greek culture was shaped by its interaction with non-Greek cultures.

## Greeks and Barbarians

The people of the first nomadic empire left no written records, but from 200 BC they dominated the heart of Asia for 400 years. They changed the world. The Mongols, today's descendants of Genghis Khan, see them as ancestors. Their rise cemented Chinese unity and inspired the first Great Wall. Their heirs under Attila the Hun helped destroy the Roman Empire. We don't know what language they spoke, but they became known as Xiongnu, or Hunnu, a term passed down the centuries and across Eurasia, enduring today in shortened form as 'Hun'. Outside Asia precious little is known of their rich history, but new evidence reframes our understanding of the indelible mark they left on a vast region stretching from Europe and sweeping right across Central Asia deep into China. Based on meticulous research and new archaeological evidence, Emperors and Barbarians traces their epic story, and shows how the nomadic cultures of the steppes gave birth to a 'barbarian empire' with the wealth and power to threaten the civilised order of the ancient world.

#### Barbarians at the Wall

Empires and Barbarians presents a fresh, provocative look at how a recognizable Europe came into being in the first millennium AD. With sharp analytic insight, Peter Heather explores the dynamics of migration and social and economic interaction that changed two vastly different worlds--the undeveloped barbarian world and the sophisticated Roman Empire--into remarkably similar societies and states. The book's vivid narrative begins at the time of Christ, when the Mediterranean circle, newly united under the Romans, hosted a politically sophisticated, economically advanced, and culturally developed civilization--one with philosophy, banking, professional armies, literature, stunning architecture, even

garbage collection. The rest of Europe, meanwhile, was home to subsistence farmers living in small groups, dominated largely by Germanic speakers. Although having some iron tools and weapons, these mostly illiterate peoples worked mainly in wood and never built in stone. The farther east one went, the simpler it became: fewer iron tools and ever less productive economies. And yet ten centuries later, from the Atlantic to the Urals, the European world had turned. Slavic speakers had largely superseded Germanic speakers in central and Eastern Europe, literacy was growing, Christianity had spread, and most fundamentally, Mediterranean supremacy was broken. Bringing the whole of first millennium European history together, and challenging current arguments that migration played but a tiny role in this unfolding narrative, Empires and Barbarians views the destruction of the ancient world order in light of modern migration and globalization patterns.

# Becoming a Barbarian

Trajan's Column, set up in the heart of Rome, was completed in 113 CE to commemorate the emperor Trajan's wars across the Danube. Its reliefs provide a uniquely detailed picture of the army at war in perfect harmony with Trajan who in his own lifetime and forever after was accounted 'The Best of Emperors'. The sculptures are a panegyric to military achievement of the troops and to leadership by their emperor, but, much more than this, they have exerted an enormous influence on modern perceptions of Roman art, architecture, warfare, politics, religion, ethnography and geography. The central purpose of the book is to provide definitive answers to questions which have been asked about Trajan's Column since the first studies of the 16th century. How were the reliefs planned and executed? Can they be used as a reliable historical source for Trajan's reign? How accurate is their depiction of the Roman army at war? What does the Column reveal about the political balance between emperor and army, and about Rome's attitude to the 'barbarian'? The Column's pedestal reliefs depicted more than 600 captured barbarian trophies, and its 200m helical frieze represents 2600 human figures engaged in frontier warfare. Never before has this vast mass of material been studied in detail, in its entirety, using modern methods of recording, comparison and analysis. The author was granted unprecedented access by the Rome authorities to scaffolding erected around the Column for conservation studies, allowing detailed photographic evidence to be collected as well as the chance to study the whole monument at close hand. The resulting book will be of interest to researchers and students of Roman imperial history, art, and the city of Rome.

# Empire and Political Cultures in the Roman World

This historical analysis of Roman-Barbarian relations from the Republic into late antiquity offers a striking new perspective on the fall of the Empire. The barbarians of antiquity, often portrayed simply as the savages who destroyed Rome, emerge in this colorful, richly textured history as a much more complex factor in the expansion, and eventual unmaking, of the Roman Empire. Thomas S. His nuanced history subtly shows how Rome's relations with the barbarians slowly evolved from general ignorance, hostility, and suspicion toward tolerance, synergy, and integration. This long period of acculturation led to a new Romano-barbarian hybrid society and culture that anticipated the values and traditions of medieval civilization.

## The Sons of Remus

THE present series of lectures is designed to give a broad and general view of the long sequence of the migratory movements of the northern barbarians which began in the third and fourth centuries A.D. and cannot be said to have terminated till the ninth. This long process shaped Europe into its present form, and it must be grasped in its broad outlines in order to understand the framework of modern Europe. There are two ways in which the subject may be treated, two points of view from which the sequence of changes which broke up the Roman Empire may be regarded. We may look at the process, in the earliest and most important stage, from the point of view of the Empire which was being dismembered or from that of the barbarians who were dismembering it. We may stand in Rome and watch the strangers sweeping over her provinces; or we may stand east of the Rhine and north of the Danube, amid the forests of Germany, and follow the fortunes of the men who issued thence, winning new habitations and entering on a new life. Both methods have been followed by modern writers. Gibbon and many others have told the story from the side of the Roman Empire, but all the principal barbarian peoples-not only those who founded permanent states, but even those who

formed only transient kingdoms-have had each its special historian. One naturally falls into the habit of contemplating these events from the Roman side because the early part of the story has come down to us in records which were written from the Roman side. We must, however, try to see things from both points of view. The barbarians who dismembered the Empire were mainly Germans. It is not till the sixth, century that people of another race-the Slavs-appear upon the scene. Those who approach for the first time the study of the beginnings of medieval history will probably find it difficult to group and locate clearly in their minds the multitude of Germanic peoples who surge over the scene in distracting confusion. The apparent confusion vanishes, of course, with familiarity, and the movements fall into a certain order. But at the very outset the study of the period may be simplified by drawing a line of division within the Germanic world. This capital line of division is geographical, but it has its basis in historical facts. It is the distinction of the West Germans from the East Germans. To understand this division we must go back for a moment into the early history of the Germans...

## Rome and the Barbarians, 100 B.C.-A.D. 400

Contemporary forms of tension and conflict among nations cannot be described in terms familiar to twentieth century history, but neither can they be reduced to a 'clash of civilizations'. The supercargo consisted of this dozen-odd fed-up ones—eight Americans, three Frenchmen and one Belgian. There was a young soldier of fortune named Carfax, recently discharged from the Pennsylvania State Constabulary, who seemed to feel rather sure of a commission in the British service. Beside him, leaning on the blistering rail, stood a self-possessed young man named Harry Stent. He had been educated abroad; his means were ample; his time his own. He had shot all kinds of big game except a Hun, he told another young fellow—a civil engineer—who stood at his left and whose name was Jim Brown. A youth on crutches, passing along the deck behind them, lingered, listening to the conversation, slightly amused at Stent's game list and his further ambition to bag a Boche. The young man's lameness resulted from a trench acquaintance with the game which Stent desired to hunt. His regiment had been, and still was, the 2nd Foreign Legion. He was on his way back, now, to finish his convalescence in his old home in Finistère. He had been a writer of stories for children. His name was Jacques Wayland.

Barbarians' is the name the Romans gave to those who lived beyond the frontiers of the Roman Empire - the peoples they considered 'uncivilised'. Drawing on the latest scholarly research, this book rejects easy generalisations to provide a clear, nuanced and comprehensive account of the barbarians and the tumultuous period they lived through.
