### Strategies and Tools for a Sustainable Rural Rio de Janeiro

This book is a compilation of recent developments in land, ecosystem, and water management in the Brazilian state of Rio de Janeiro. The state is located in the biodiversity hotspot of the Atlantic Forest (Mata Atlântica), a biome characterized by high biological diversity and endemism. At the same time the state of Rio de Janeiro emerged to one of the economic hubs in Latin America. This development process has been accompanied by population growth, industrialization, urbanization, as well as consumption and degradation of land and water resources. In the past years many efforts have been made to stop or at least slow down these degradation processes and restore degraded environments with the overall goal to bring together sustainable management of natural resources, nature conservation, and economic development. The different chapters are written by researchers and practitioners of the German Brazilian project INTECRAL (Integrated Eco Technologies and Services for a Sustainable Rural Rio de Janeiro), the rural development program Rio Rural under the state secretary for agriculture and animal husbandry, as well as invited scientists from Brazilian universities and research institutes. It bridges existing gaps between science, policies, and practice in rural development.

### Rural Sustainable Development in the Knowledge Society

Based on the EU-funded CORASON research project, this volume brings together and compares studies into rural and sustainable development processes in 12 European countries. In doing so, it identifies key trends and reveals the changing nature of development processes on the way towards a knowledge society. The book examines the differences between the preconditions and contexts relevant

to rural development strategies and those relevant to sustainable development strategies. It explores whether the concept, goals and nature of rural development is better understood and adopted by rural actors than those of sustainable development. Finally by focusing on the ideas and practices of sustainable resource management- a component in both rural and sustainable development objectives-it links with knowledge used by actors involved in rural development.

### Environmental Impact of Land Use in Rural Regions

The concern over groundwater contamination has focused attention on the processes that influence the fate of chemicals in soil water systems. A major concern of groundwater contamination is the passage of these chemcials through the unsaturated zone and the relatively thin cover layers overlying the aquifers. Pollution due to diffuse sources is probably the most difficult to model. This is because the loads are usually non-homogeneous and they are also governed by spatially and temporally non-homogeneous, but dynamic, processes of chemical and biochemical phenomena. In this book, the estimation techniques and transfer functions of required input data from existing databases in geographic information systems are provided. Spatially variable input data, such as the type of soil, hydrological conditions, intensity of land use and atmospheric deposit of pollutants, are derived from basic land and climate characteristics.
