It touched a raw nerve in the late-Victorian imagination. As Gerard Manley Hopkins wrote to a friend, "You are certainly wrong about Hyde being overdrawn; my Hyde is worse." Vladimir Nabokov asserted in his Cornell lecture "that it was a fable belonging to the same order of art as...Madame Bovary."
