Marshall had actually worked with Adams before as a diplomat to France during the XYZ Affair (which is a whole story unto itself), and then as secretary of state.

Jefferson found out about Burr's shenanigans and declared him a traitor, so he was arrested and brought to court... at which point he was found to be doing nothing that violated American law, so he was released and then arrested and brought to court... and released again, until he was arrested for a third time, and with evidence of private communications with British and Spanish diplomats he was charged with a misdemeanor. Then he was brought to Marshall (albeit not the Supreme Court) at which point it was discovered that the most damning evidence against him had been forged by his would-be co-conspirator.

Actually, some of the democratic-republicans had recently turned into democrats, the parties were undergoing a big shift at the time, but there was nary a federalist in sight.
