Questo libro fornisce, infine, elementi di diritto penale e di procedura penale, affrontando in maniera chiara ed esaustiva tematiche estremamente tecniche relative ai reati, le cause oggettive di esclusione del reato, la responsabilità oggettiva, il Giudice, il pubblico ministero, l'indagato, l'imputato, la persona offesa dal reato ed il loro difensore.

The book examines the nature of global problems as well as the type of responses that are needed, in order to exemplify the substance of global bioethics. It discusses the ethical frameworks that are available for global discourse and shows how these are transformed into global governance mechanisms and practices.
