The fascination with literary dependency in the most popular approaches to the synoptic problem has been built upon a faulty presupposition: that oral tradition is incapable of producing the word for word verbal agreement found in the synoptic accounts. Recent research in the area of oral tradition has shown that this is not the case, but we still rely on increasingly complicated literary models to explain the relationships between the Synoptic Gospels. This book engages in comparative analysis of Old Greek quotations found in more than one of the Synoptic Gospels, along with the material that surrounds these quotations. The resulting conclusions indicate that oral sources may better explain the similarities and differences found in the Synoptic Gospels, and that we ought to reexamine our foundational presuppositions in order to craft a better model for understanding the origins of the Synoptic Gospels. The hope is that the reader will join the author in seeking to better understand these books that include the climax of the greatest story of all time: the true story of people marred by sin, and their creator who seeks after them as he redeems all things to himself.

Diatessarica. 2: The Corrections of Mark Adopted by Matthew and Luke, by Edwin A. Abbott

This study traces the debate surrounding Luke's use of the Gospel of Mark and special sources, such as Proto-Luke, in a section of the passion narrative (Lk 22,54-23,25). The survey covers roughly the period from the 1880's to 1997. Part I details the development from P. Feine to the 1960's. Part II begins with G. Schneider continuing up through 1997. In treating each scholar's position, the author reviews their underlying Synoptic theory, their source theory in the passion in general, then the trial of Pilate, and finally the trial before Herod. Part III is devoted to an interpretation of Lk 23,6 - 16. Part IV contains the list of abbreviations, the bibliography, and three appendices: (1) Special LQ vocabulary and constructions according to J. Weiss; (2) Lukan priority theories; and (3) the Gospel of Peter and its relation to the Herod pericope. Part IV concludes with the name index. An Introduction to the New Testament and the Origins of Christianity

This volume examines the synoptic problem and argues that the similarities between the gospels of Matthew and Luke outweigh the objections commonly raised against the theory that Luke used the text of Matthew in composing his gospel. While agreeing with scholars who suggests that memory played a leading role in ancient source-utilization, Eric Eve argues for a more flexible understanding of memory, which would both explain Luke's access of Matthew's double tradition material out of the sequence in which it appears in Matthew, and suggest that Luke may have been more influenced by Matthew's order than appears on the surface. Eve also considers the widespread ancient practice of literary imitation as another mode of source utilization the Evangelists, particularly Luke, could have employed, and argues that Luke's Gospel should be seen in part as an emulation of Matthew's. Within this enlarged understanding of how ancient authors could utilize their sources, Luke's proposed use of Matthew alongside Mark becomes entirely plausible, and Eve concludes that the Farrer Hypothesis of

Matthew using Mark, and Luke consequently using both gospels, to be the most likely solution to the Synoptic Problem.

Hunting for the word of God

For the first time, the Gospel material unique to both Matthew and Luke is brought together into one volume--in both Greek and English. For more than a century, New Testament scholars have asserted that Matthew and Luke drew on sources in addition to Q and Mark during the composition of their Gospels. For convenience, the non-paralleled material in Matthew has traditionally been labeled "M," and the non-paralleled material in Luke has traditionally been labeled "L." We learn only from Matthew, for example, particular stories like Joseph and Mary's escape to Egypt and the Great Commission; from Luke stories like the Prodigal Son and Jesus' appearance on the Emmaus road. Studying the material unique to each Gospel in isolation from their narrative contexts will allow students and scholars alike to engage these stories on their own. In this book, the individual special pericopae from Matthew and Luke are collected and arranged in Greek and English in the order in which they appear in the Greek New Testament. An introductory essay is provided to introduce readers to the Synoptic Problem, the notions of M and L and where they come from, what the parameters are for selection, and the critical debate, so that readers know how the selections were made and what is being asserted by their inclusion. This book will be a wonderful teaching tool for seminary and university professors, and will facilitate student engagement with distinctive Matthean and Lukan stories. It will also be a valuable resource for New Testament scholars doing research on this special material, since having it all in one place will no longer require them to search for the distinctive passages among the larger Gospel narratives.

Gospel Reading and Reception in Early Christian Literature

Burkett offers a new viewpoint on the much-debated Synoptic Problem. He contends that each theory regarding the Synoptic Problem is problematic. Each presents a case for the mutual dependence of one source upon another - for example, Matthew and Luke depend primarily on Mark, but use each other where they report the same story not contained already in Mark. Neither Mark nor Matthew nor Luke served as the source for the other two, but all depended on a set of earlier sources now lost. The relations between the Synoptic Gospels are more complex than the simpler theories have assumed.

In the spirit of Ludolph of Saxony (c. 1295-1378) and Ignatius of Loyola (1491-1556), The Fourfold Gospel invites the reader into the mystery of God's redemption in Jesus Christ. All the parallel passages in the Gospels are glossed together, along with the unique material, using a medieval interpretive approach called the Quadriga or the acronym PaRDeS in Hebrew. Meditating on the literal, canonical, moral, and theological senses of Scripture offers a scaffolding for the spiritual formation of the reader. This volume, in addition to a thorough introduction to the method and the Gospels, focuses on the beginning of the story--the birth, baptism, and temptations of Christ.

The Fourfold Gospel, Volume 1

The Bible is simply a love letter compiled into sixty-six books and written over a period of sixteen hundred years by more than forty authors living on three continents. Although theauthors came from different backgrounds, there is one message, one theme, one thread that runs throughout the entire Bible from the first book, Genesis, to the last book, Revelation. That message is God's redeeming love for mankind--a message that is as relevant for us today as it was two thousand years ago. These five books (Matthew, Mark, Luke, John, and Acts) begin with the birth of Jesus Christ and conclude

with the first imprisonment of the apostle Paul about six decades later. Over the course of these decades, God introduced elements of His sovereign plan that turned the world upside down. He moved from an emphasis on the nation of Israel to an emphasis on the church, from a covenant of law to a covenant of grace, from His Holy Spirit merely coming upon people to actually indwelling them, and from commanding Israel to live in such a way as to attract others to commanding the church to disperse throughout the world and make disciples of all nations. The Gospels give us four similar but distinct accounts of Jesus the Messiah, God's Son. His birth, childhood, ministry, teaching, miracles, arrest, trials, death, and resurrection are all handled differently by the four authors, Matthew, Mark, Luke, and John. But in every record, by the time the tomb of Jesus was empty, the world had been changed. While the Gospels tell the story of the life of Christ, the book of Acts tells the story of the church of Christ. From its founding on the Day of Pentecost in the city of Jerusalem, through its expansion around the then-known world, to its crisis when the apostle Paul was imprisoned in Rome for the first time, the story is one of excitement, intrigue, incredible growth, and life-changing encounters.

Jesus

The Gospel of Jesus is a single edition of the four gospels of Matthew, Mark, Luke, and John, combined into one complete story of the life of Jesus. Many details are found to be omitted from one gospel version to the next, and some events are not mentioned at all. By combining details from each gospel and presenting the events as one version, a greater understanding can be obtained. For instance, only in Luke does it reveal that Jesus turned and looked at Peter when he denied knowing Him the third time. Again, only in John is it recorded that when Jesus was about to be arrested and He told them He was the one they sought, they fell backward to the ground! Many such details are easily forgotten, yet are essential in order to fully grasp an understanding of the events that occurred during this time. The Gospel of Jesus is for the seasoned reader of the Bible as well as the new student or young adult. It is formatted as any normal book with updated pronouns and verb usage. Chapter and verse references are found at the end of each event which allows a more consistent flow of thought without interruption. The Gospel of Jesus is the first volume in the Book by Book series. The first two chapters of the book of Acts was included because it pertains to the immediate events that occurred after the resurrection and appearances prior to the ascension of Jesus into Heaven. The remaining chapters of Acts are found in Volume III, along with the book of Revelation. Volume II consists of the Letters of the New Testament, which have been arranged chronologically according to the general acceptance of the year in which they were written. This is purely for historical accuracy.

The New Testament Historical Books

Was the Gospel of Mark Written First? Were the Gospel Writers Plagiarists? What is the Q Document? What about Document Q? Critical Bible scholars have assumed that Matthew and Luke used the book of Mark to compile their Gospels and that they consulted to supplementary source, to document the scholars call Q from the German Quelle, or source. From the close of the first century AD to the 18th century, the reliability of the Gospels was never really brought into question. However, once we have called the period of enlightenment, especially from the 19th century onward, some critical Bible scholars viewed the Gospels not as the inspired, inerrant Word of God but rather as the word of man, and a jumbled word at that . In addition, they determined that the Gospels were not written by Matthew, Mark, Luke, and John, saying the Gospels were written after the apostles, denying that the writers of the Gospels had any firsthand knowledge of Jesus; Therefore, for these Bible critics such men were unable to offer a record of reliable history. Moreover, these critical Bible scholars came to the conclusion that the similarities in structure and content in the synoptic (similar view) Gospels (Matthew, Mark, and Luke), suggests that the evangelists copied extensively from one other. Further, the critical Bible scholars have rejected that the miracles of Jesus and his resurrection have occurred as recorded in the Gospels. Lastly, some have even gone so far as to reject the historicity of Jesus himself.
