Indians in London

The Indian diaspora in Australia and New Zealand represents a successful ethnic community making significant contributions to their host societies and economies. Indians and the Antipodes

People's transnational mobilities, their activities to build homes in their countries of residence and their connectivities have resulted in multiplicities of belonging to encountered, imagined and represented communities operating within various political contexts. Migrants and their descendants labor to form and transform relations with their country of origin and of residence. People who see their origins in India but are now living elsewhere are a case in point. They have been establishing worldwide home places, whose growing number and vibrancy invite reconsideration of Indian diasporic communities and contexts in terms of 'India(s) beyond India.' Issues of belonging in Indian diasporas include questions of membership not only in the nation of previous and present residence and/or the nation of origin, but also in other communities and networks in political, economic, religious and social realms at local, regional or global levels. Yet, belonging – and especially simultaneous belonging – to various formations is rarely unambiguous. Rather, belonging in all its modes may entail dilemmas that arise from inclusions and exclusions. Bearing in mind such processes, the contributions to this volume endeavor to provide answers to the question of what kinds of difficulties members of Indian communities abroad encounter in connection with their identifications with and participation in specific collectivities. The underlying argument of all the essays collected is that members of Indian diasporas develop strategies to cope with the dilemmas they face in connection with their sense of belonging to particular communities, while they are subjected to specific power relationships. Thus, the volume sheds light on the ways in which dilemmas of belonging are being negotiated in intercultural fields.

India's Missed Opportunity

Although the Bene Israel community of western India, the Baghdadi Jews of Bombay and Calcutta, and the Cochin Jews of the Malabar Coast form a tiny segment of the Indian population, their long-term residence within a vastly different culture has always made them the subject of much curiosity. India Once Ruled the Americas!

Indians in Southeast Asia

For the century and a half before the Second World War, Britain dominated the Indian subcontinent. Britain's East India Company ruled enclaves of land in South Asia for a century and a half before that. For these 300 years, conquerors and governors projected themselves as heroes and improvers. The British public were sold an image of British authority and virtue. But beneath the veneer of pomp and splendour, British rule in India was anxious, fragile and fostered chaos. Britain's Indian empire was built by people who wanted to make enough money to live well back in Britain, to avoid humiliation and danger, to put their narrow professional expertise into practice. The institutions they created, from law courts to railway lines, were designed to protect British power without connecting with the people they ruled. The lack of affection between rulers and ruled finally caused the system's collapse. But even after its demise, the Raj lives on in the false idea of the efficacy of centralized, authoritarian power. Indians responded to the peculiar nature of British power by doing things for themselves, creating organisations and movements that created an order and prosperity of its own. *India Conquered* revises the way we think about nation-building as much as empire, showing how many of the institutions that shaped twentieth century India, Pakistan and Bangladesh were built in response to British power. Anglo-Indians

Representations of Indian economic life have played an integral role in discourses about poverty, social policy, and cultural difference but have received surprisingly little attention. Daniel Usner dismantles ideological characterizations of Indian livelihood to reveal the intricacy of economic adaptations in American Indian history. Officials, reformers, anthropologists, and artists produced images that exacerbated Indians' economic uncertainty and vulnerability. From Jeffersonian agrarianism to Jazz Age primitivism, European American ideologies not only obscured Indian struggles for survival but also operated as obstacles to their success. Diversification and itinerancy became economic strategies for many Indians, but were generally maligned in the early United States. Indians repeatedly found themselves working in spaces that reinforced misrepresentation and exploitation. Taking advantage of narrow economic opportunities often meant risking cultural integrity and personal dignity: while sales of baskets made by Louisiana Indian women contributed to their identity and community, it encouraged white perceptions of passivity and dependence. When non-Indian consumption of Indian culture emerged in the early twentieth century, even this friendlier market posed challenges to Indian labor and enterprise. The consequences of this dilemma persist today. Usner reveals that Indian engagement with commerce has consistently defied the narrow choices that observers insisted upon seeing.

These Are the Anglo Indians

This is the brilliantly told story of one of the wonders of the modern world - how in less than a hundred years the British made themselves masters of India. They ruled it for another hundred, departing in 1947, leaving behind the independent states of India and Pakistan. Deloria suggests that imagining Indians has helped generations of white Americans define, mask, and evade paradoxes stemming from simultaneous construction and destruction of these native peoples. In the process, Americans have created powerful identities that have never been fully secure.

Anglo-Indians, Neglected Children of the Raj

Jews and India

He developed Edinburgh's first Penny Post system, launched a weekly magazine and shamelessly exploited his experiences for profit. Brimming with action and adventure, Indian Peter is a true-life tale of abduction, war and courtroom drama. It is an inspiring story of courage, fortitude and one man's determination to survive against seemingly insurmountable odds.

India Conquered

Indian Writers attempt to locate diasporic voices in the interstitial spaces of countless ideologies. The anthology provides a critical examination of dislocated diasporic subjects - those who have adjusted to the dislocation well, those who have chosen the hybrid spaces for empowerment, those who are dragged forcefully to various territories, and yet those who gleefully inhabit trans-local spaces. Indian Diaspora has prevailed and enriched almost every country in the world. Even in the most unlikely places you are like to find small glitters of the Indian community: a community which celebrates the festivals such as Divali, Eid and Holy and Gurunanak jayanti which represents the Unity in Diversity of India. Even so, there is one special branch of the Indian diasporic Banyan tree which has made unique contribution to the world, the world of Literature. The reason for the writers of the Diaspora writing about India can be attributed to dictum that "you can take the man out of his homeland but you can't get the homeland out from the person." A person might go far away from India but cannot get over the reminiscences, the memories and the feelings attached to the homeland because these would always be with him/her. The country of a person's origin, the native land, always has an attraction and since distances make the heart grow fonder, as the saying goes, writers of the Indian Diaspora are persuaded to write about it. This, in a way, is essential to re-establish and sustain their connectivity to their motherland.

Contemporary Indian Diaspora

Adopting the concept of diaspora--literally dispersal, or the scattering of a people--to the historical and contemporary presence of people of Indian subcontinental origin in other areas of the world, Emmanuel Nelson uses this paradigm to analyze Indian expatriate writing. English Literature

In the wake of the steady expansion and more recent explosion of Anglo-Indian and Indo-Anglian writing, and following the success of Salman Rushdie's *Midnight's Children*, the literature of the Indian diaspora has become the object of close attention. As a body of literature, it simultaneously represents an important multicultural perspective within individual 'national' literatures (such as those of Canada or Australia) as well as a more global perspective taking in the phenomena of transculturalism and diaspora. However, while readers may share an interest in the writing of the Indian diaspora, they do not always interpret the notion of 'Indian diaspora' in the same way. Indeed, there has been much debate in recent years about the appropriateness of terms such as diaspora and exile. Should these terms be reserved for the specifically historical nature of problems encountered in the process of acquiring new nationality and citizenship, or can they be extended to the writing of literature itself or used to describe 'economic' migration arising out of privilege? As a response to these debates, *Shifting Continents/Colliding Cultures* explores the aftermath of British colonialism on the Indian subcontinent and Sri Lanka, including the resulting diaspora. The essays also examine zones of intersection between theories of postcolonial writing and models of diaspora and the nation. Particular lines of investigation include: how South-Asian identity is negotiated in Western spaces, and its reverse, how Western identity is negotiated in South-Asian space; reading identity by privileging history; the role of diasporic women in the (Western) nation; how diaspora affects the literary canon; and how diaspora is used in the production of alternative identities in films such as Gurinder Chadha's *Bhaji on the Beach*.
