Keeping Faith

President Jimmy Carter, like all his predecessors since World War II, experienced the blurring of lines between foreign and domestic politics while, paradoxically, the contrasts between those lines became more pronounced. In nearly every arena of domestic and foreign policy, he had to deal with the intrusion of the politics of both spheres. The Leadership Crisis

Jimmy Carter from Plains, Georgia, a graduate of the Naval Academy, was President for one term. A peanut farmer when he became governor of Georgia, he promoted racial integration during his terms in the state house as well as in the White House. Carter's foreign policy introduced the concept of human rights around the world, and he signed the SALT treaty with the Soviet Union, reducing the numbers of nuclear weapons. Although Carter made progress towards peace between Arabs and Israelis in the Middle East, his administration was undone by the taking of American hostages in Iran. As an ex-president, Carter continues to be active promoting peace internationally.

State of the Union Addresses

In September 1978, William Quandt, a member of the White House National Security Council staff, spent thirteen momentous days at Camp David, the presidential retreat in Maryland, where three world leaders were holding secret negotiations. When U.S. President Jimmy Carter, Egyptian President Anwar Sadat, and Israeli Prime Minister Menachem Begin emerged on September 17, they announced a monumental accomplishment: the first peace agreement between Israel and one of its Arab neighbors. Wright also explores the significant role played by Rosalynn Carter. What emerges is a riveting view of the making of this unexpected and so far unprecedented peace. Wright exhibits the full extent of Carter's persistence in pushing an agreement forward, the extraordinary way in which the participants at the conference--many of them lifelong enemies--attained it, and the profound difficulties inherent in the process and its outcome, not the least of which has been the still unsettled struggle between the Israelis and the Palestinians. In "Thirteen Days in September," Wright gives us a resonant work of history and reportage that provides both a timely revisiting of this important diplomatic triumph and an inside look at how peace is made.

The United States and the Middle East

Nobel Peace Laureate argues that this is a unique time for achieving peace in the Middle East - and offers a comprehensive plan to do just that.

James E. Carter, 1924-

Jimmy Carter was the 39th President of the United States and served from 1977 to 1981. Prior to his presidency, he served as the governor of Georgia from 1971 to 1975. Carter was born in Plains, Georgia in 1924 and grew up on his family's peanut farm. He graduated from the United States Naval Academy in 1946 and served in the Navy until 1953. Carter's presidency was marked by several significant accomplishments, including the Camp David Accords, which led to a peace treaty between Egypt and Israel. He also created the Department of Energy and signed the Panama Canal Treaty, which transferred control of the canal to Panama. However, Carter faced several challenges during his presidency, including an energy crisis, a stagnant economy, and the Iran hostage crisis. He was defeated in his re-election bid by Ronald Reagan in 1980. After leaving office, Carter became known for his work in global peace and humanitarian efforts.
