South African Digest

Building on global interest in migration development, the volume draws attention to one of the most important migration systems in sub-Saharan Africa. It reviews South Africa's approach to international migration in the post-apartheid period from a regional development perspective, highlighting key policy issues, debates, and consequences. The authors find at least three areas where migration is resulting in important development impacts. First, by offering options to those affected by conflict and crises in a region that has limited formal disaster management and social protection systems. Second, by mitigating shortcomings and distortions in regional labour markets. Third, by providing support to struggling rural economies and ever expanding urban areas in terms of livelihoods and social capital transfers. Chapter One consists of a study of the country's historical experience of migration and, in particular, analyses the changes in official attitudes throughout the twentieth century, indicating the roots of contemporary ideas and policy dilemmas. Chapters Two, Three, Four and Five complement this analysis of the South African State's capacity to reform and manage the South African migration situation by looking at often neglected dimensions: the first explores the question of skilled labour, a crucial question given the unbalanced structure of the South African labour market; the second examines the impact of migration on local government in South African cities and specifically implications for urban planning, service delivery, health, security, and political accountability; the third analyses the nature of undocumented migration to South Africa and the challenges it raises to both State and non-State actors; The book concludes with an examination of health as a critical issue when examining the relationship between migration and development in South Africa, in light of recent empirical data.

Scapegoats of the Empire is an autobiography by George Witton. Witton was a lieutenant in the Bushveldt Carbineers in the Boer War in South Africa during the early 20th century. Excerpt: "Life in camp at Beira was almost a repetition of Langwarrin, being principally occupied in attending to and exercising the horses. On my arrival in camp I was instructed by Captain Dallimore to act as squadron-quartermaster-sergeant; my duties were to see that rations and forage were drawn daily and all camp equipment kept in order. Occasionally I went out on the veldt when exercising the horses; there appeared to be plenty of game about, and whenever a small buck rose up close to us there would be a hue-and-cry after it. Sometimes we would succeed in running it down in the long grass."

Witton's main assertion, as indicated by the book's provocative title, was that he, Morant, and Handcock were made scapegoats by the British authorities in South Africa - that they were made to take the blame for widespread British war crimes against the Boers, and that the trial and executions were carried out by the British for political reasons, partly to cover up a controversial and secret "no prisoners" policy by Kitchener, and partly to appease the Boer government over the killing of Boer prisoners, in order to facilitate a peace treaty; the Treaty of Vereeniging was signed on 31 May 1902.

Honeybees are as small as flies or as large as hornets, nesting in nar row cavities of trees and rocks or in the open on large limbs of trees 30 m above ground. They occur in tropical zones and in the forests of the Ural mountains, they survive seven months of winter and even longer periods of drought and heat. Historically, they lived through a extended time of stagnation in the tropics from the mid-Tertiary, but then experienced an explosive evolution during the Pleistocene, re sulting in the conquest of huge new territories and the origin of two dozen subspecies in Apis mellifera. This vast geographic and ecologic diversification of the genus Apis was accompanied by a rich morphological variation, less on the level of species than at the lowest rank, the subspecies level. Variation being exclusively of a quantitative kind at this first step of speciation, tradi tional descriptive methods of systematics proved to be unsatisfactory, and honeybee taxonomy finally ended up in a confusing multitude of inadequately described units. Effective methods of morphometric-sta tistical analysis of honeybee popUlations, centered on limited areas, have been developed during the last decades. Only

the numerical characterization of the populations, together with the description of behavior, shows the true geographic variability and will end current generalizations and convenient stereotypes.
