## Requiem for Reality

Critical Race Theory, like most ideologies before it, promises an earthly paradise premised on ceaseless revolution, but instead of delivering on this promise, it produces a terrestrial hell echoing the inner nihilism of modern life. Contemporary social justice movements, just like progressivism, the New Deal, and post-Civil War Southern Democrats, place Westerners in bondage rather than delivering on the promise of unlimited freedom. Requiem for Reality responds to the widening pendulum shifts of our age. These developments consume and incense the nation. These shifts offer a bewildering set of claims grounded in the presumption that race and other forms of human identity explain all forms of disparity and inequality. Against such claims, it is crucial to distinguish between a development narrative and a bias narrative for the purpose of explaining ethnic disparity. The development narrative is grounded in data that often deliver unwelcome facts. The facts show that Asian Americans, as well as West Indian blacks, often do better than white Americans in schooling, per capita income, and crime rates. Indeed, Syrian Americans, Korean Americans, Indonesian Americans, Taiwanese Americans, and Filipino Americans experience significantly higher median household incomes than whites and higher test scores, lower incarceration rates, and longer life expectancies. Oblivious to such facts, the bias narrative, on the other hand, grounds itself in the "white privilege" thesis suggesting that only race matters. Surfacing from the toxic pit of ideology, the bias narrative emphasizes the racist claim that African Americans are the only ethnic group in the world who cannot succeed under less-than-ideal conditions. Separated from important facts, this narrative often substitutes absolute Neo-pagan certainties originating in a make-believe world for commonplace notions of truth and reality. As such, the "white privilege" thesis, rather than improving the conditions of African Americans and others, offers a utopian dream that threatens to become a national nightmare. The urgent pursuit of utopia reflects trends that are largely anthropological, sociological, and more spiritual than political. Responding to these developments, which have given rise to victimhood claims within gender and transgender categories will require more than argumentation, rational analysis, superior logic, or even the inauguration of a Hanging Judge. It will require courage because otherwise, Chairman Mao's forecast, stating that there is a great disorder under heaven and the situation is excellent, may come true here just like it has already come true for China.

#### The God Delusion

The God Delusion caused a sensation when it was published in 2006. Within weeks it became the most hotly debated topic, with Dawkins himself branded as either saint or sinner for presenting his hard-hitting, impassioned rebuttal of religion of all types. His argument could hardly be more topical. #### Faith of the Fatherless

In this updated, expanded edition, starting with Freud's "projection theory" of religion - that belief in God is merely a product of man's desire for security - Professor Vitz argues that psychoanalysis actually provides a more satisfying explanation for atheism. Disappointment in one's earthly father, whether through death, absence, or mistreatment, frequently leads to a rejection of God. A biographical survey of influential atheists of the past four centuries shows that this "defective father hypothesis" provides a consistent explanation of the "intense atheism" of these thinkers. A survey of the leading defenders of Christianity over the same period confirms the hypothesis, finding few defective fathers. Vitz concludes with an intriguing comparison of male and female atheists and a consideration of other psychological factors that can contribute to atheism. Professor Vitz does not argue that atheism is psychologically

determined. Each man, whatever his experiences, ultimately chooses to accept God or reject him. Yet the cavalier attribution of religious faith to irrational, psychological needs is so prevalent that an exposition of the psychological factors predisposing one to atheism is necessary.

# Against Atheism

In recent years a number of bestselling books have forcefully argued that belief in God can no longer be defended on rational or empirical grounds, and that the scientific worldview has rendered obsolete the traditional beliefs held by Christianity, Judaism, and Islam. The authors of these books—Richard Dawkins, Daniel Dennett, Sam Harris, Christopher Hitchens, and Victor J. Stenger—have come to be known as the "New Atheists." Predictably, their works have been controversial and attracted a good deal of critical reaction. In this new book, Victor J. Stenger disputes the claim of many critics that the question of whether God exists is beyond the ken of science. On the contrary, he argues that absence of evidence for God is, indeed, evidence of absence when the evidence should be there and is not. Turning from scientific to historical evidence, Stenger then points out the many examples of evil perpetrated in the name of religion. He also notes that the Bible, which is still taken to be divine revelation by millions, fails as a basis for morality and is unable to account for the problem of unnecessary suffering throughout the world. Finally, he discusses the teachings of ancient nontheist sages such as Buddha, Lao Tzu, and Confucius, whose guidelines for coping with the problems of life and death did not depend upon a supernatural metaphysics. Stenger argues that this "way of nature" is far superior to the traditional supernatural monotheisms, which history shows can lead to a host of evils. The New Atheism is a well-argued defense of the atheist position and a strong rebuttal of its critics.

This is why scientists cannot explain the origin of the proposed singularity and why some scientists seek an alternative to the Big Bang model of our universe, even resorting to logical absurdities such as the universe creating itself out of nothing while in the presence of something. With the reality of God being his presupposition for what follows, the author examines the case for monotheistic religions versus polytheistic, concluding that the latter are antithetical to a God who is one. Left with a choice between Judaism, Christianity, and Islam, he concludes that if God has communicated his guidance for living to any, it is most likely Judaism as recorded in the Hebrew scriptures. The question becomes, Which parts of those scriptures were intended for the children of Israel alone, and which were for all people for all time? Researching ever deeper, he reveals what he has come to believe about how God wants us to relate to him and the specific guidance that should be reworded for contemporary times. The spirit of Torah is so much more than the mere words.

He makes an impassioned, intelligent case against religious and secular fundamentalism, which seeks to divide the world into those worthy of moral and intellectual consideration and those who should be condemned, silenced and eradicated.
